

Can One Person Bring Down the Federal Reserve?

Watch out, greedy bankers; fired LA school teacher says abolishing Fed her mission

AFP readers were recently introduced to Patricia McAllister, a courageous California schoolteacher who spoke out against Jewish bankers at an Occupy LA rally. As a result, the Los Angeles Unified School District fired her—without explanation—from jobs at both the city and county level. Over the past few weeks, AFP has received numerous letters from readers asking how they could help Ms. McAllister. In response, on Nov. 11 this writer followed up by interviewing her.

“Life has changed drastically since my initial comments went viral,” she said. “I’ve realized that it’s my calling to take away control of the Federal Reserve from Zionist Jews. The president, Congress and Supreme Court won’t do anything about the Fed, so now it’s up to the people. It’s our biggest problem.”

Although times are hard because her insurance has been cut off, and the union won’t provide assistance due to her firing, Ms. McAllister has received a great deal of support through an online teachers news group. She stated: “My case affects their freedom of speech, too, because teachers are worried about what they can say without getting fired.”

In this same vein, Ms. McAllister made another vital point. “Americans need to know about the Jewish people, especially those in the media,” she said. “They spread all this dirt and scandals about everyone else, but keep everything quiet about themselves.”

On another note, she offered this unique viewpoint. “I have a message for Christians,” she said. “I hear all this talk about the world ending. Well, I’ve found the devil in the Federal Reserve, and it’s the Zionist Jews.”

Considering the travails and financial hardships now facing her, AFP asked if she’d do it all over again. Ms. McAllister enthusiastically replied: “Yes, I sure would. In fact, I’m only getting started. Occupy LA gave me an opportunity to let my voice be heard.”




