I, PAUL SHERIDAN, being first duly sworn, depose and state as follows:

1. My name is Paul Sheridan. I reside in the County of Wayne, State of Michigan. I am over the age of 21. I am the defendant in the case of Chrysler Corporation v Paul Sheridan. I have reviewed the Verified Complaint filed by Chrysler, together with the attachments thereto including the Affidavits of Martin Levine, John M. Fonger, Michael J. Krotche, Dennis C. Malecki and Mark W. Crossman.

2. Paragraph 8 of Chrysler's Verified Complaint alleges that I, upon being questioned by investigators on behalf of Chrysler, admitted providing crash test results to a third party not employed by Chrysler. This allegation is untrue. I did not provide crash test results to a third party not employed by Chrysler.

3. Paragraph 10 of Chrysler's Verified Complaint alleges that I admitted knowledge that a person I had allegedly given copies of crash test result documents to had, in turn, given these documents to Joseph Bohn, a journalist employed by the Automotive News. This allegation is untrue. I never gave copies of crash test documents to a third party, nor did I admit knowledge that a third party had given copies of crash test results documents to Joseph Bohn.

4. I understand that the identity of the third party allegedly in question is Seymour Kliger. I specifically indicated to the Chrysler investigators that I had not given copies of crash test results documents to Mr. Kliger and that he, in turn, could not, therefore, had given such crash test results documents to Joseph Bohn.
