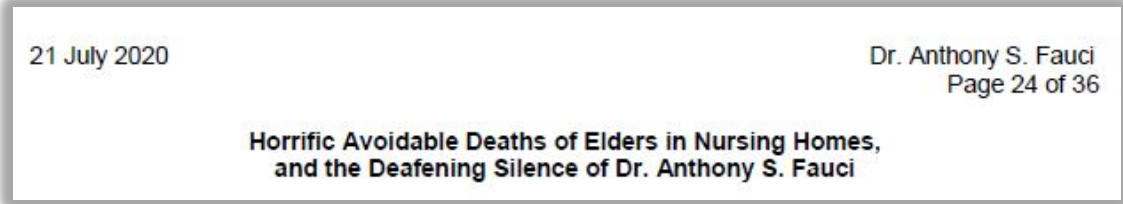

Your phrase “inherited him” might be appropriate to a stray animal that you decided to take on.

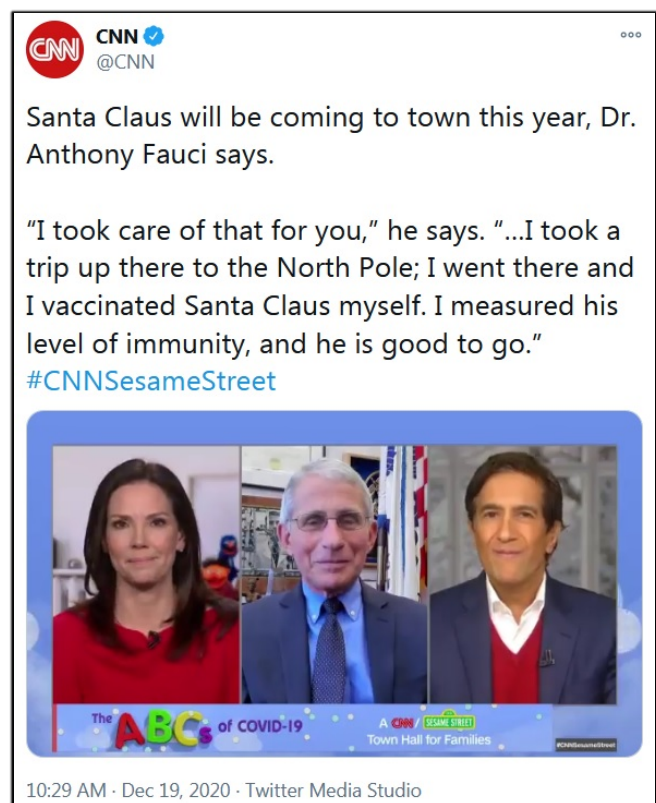

## Utah Medical Examiner says 39-year-old mom’s death 4 days after taking COVID vaccine is ‘temporally related’
