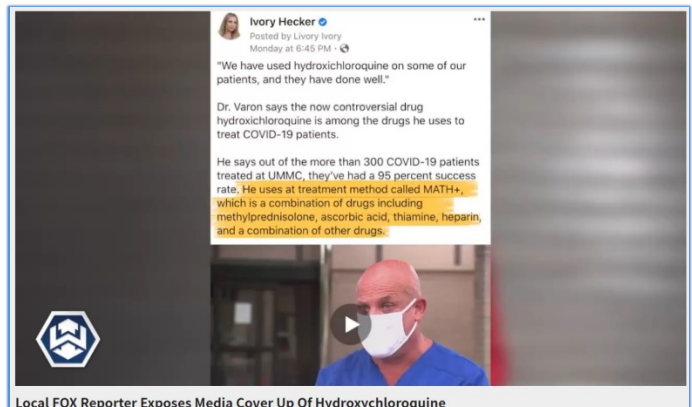
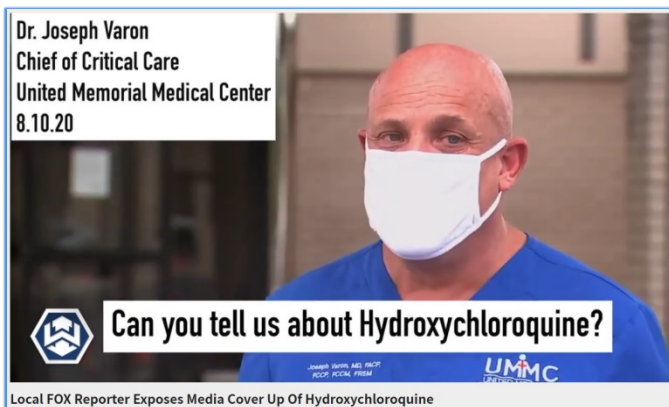
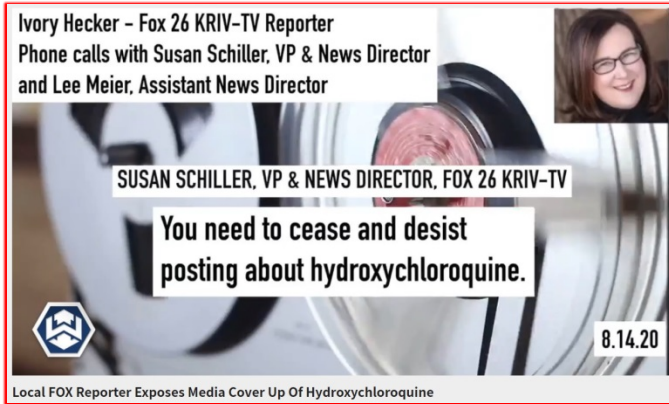
Reference 6 is enclosed; References 1 – 5 are available by hyperlinks listed below. I will emphasize some of the points made throughout the references in the following discussion.

On Sunday, 20 June 2021, the program 'Sunday Morning Futures' featured an interview by Fox News host Maria Bartiromo of Senator Ron Johnson (R-WI) and Dr. Pierre Kory:



They presented the *overwhelming* evidence of positive outcomes for COVID-19 outpatients, when those patients were treated early and with low cost treatment protocols, which include(d) the drugs Ivermectin and hydroxychloroquine. My References have been discussing these positive outcomes, **but I have also openly declared that manipulations by people such as Dr. Anthony Fauci, which consciously and specifically subverted these treatment protocols, constitute crimes; that those manipulations need to be litigated as criminal.** **My declarations have been especially focused upon the COVID-19 nightmares and avoidable deaths in the nursing homes.**

However, Dr. Fauci is just one person connectable to COVID-19 'crimes against humanity.' Fox News is not faring much better . . . Maria Bartiromo has not been threatened or dismissed by local New York Fox News management . . . for *her* June 20, 2021 report on hydroxychloroquine and Ivermectin . . . But the same cannot be said of Houston-based KRIV-26 Fox News reporter **Ms. Ivory Hecker**:



Certainly, you are party to the dismissal of Ms. Ivory Hecker. From Page 2 above, her dismissal was recommended by Ms. Lee Meier and Ms. Susan Schiller, but the directive came from your subordinate, Mr. D'artagnan Bebel, the General Manager at KRIV-26 Fox News in Houston, Texas (at left):



For context, the instant matters do not accredit the adolescent polemic that a former Fox News reporter was merely “disgruntled,” or that her report material is the equivalent of petty gossip: **The instant matters and the associated reports involve the safety and well-being of billions of human beings.**

Reasonably calculated to produce injury !? It is well-known, worldwide, that COVID-19 is especially dangerous for the elderly. This fact was determined early-on. Despite this, governors ranging from our birth state of New York, to California, to New Jersey, to Michigan, etc., ordered; let us say, FORCED numerous nursing homes to accept into residency those suspected to be “COVID-19 positive,” some of whom were convicted felons.

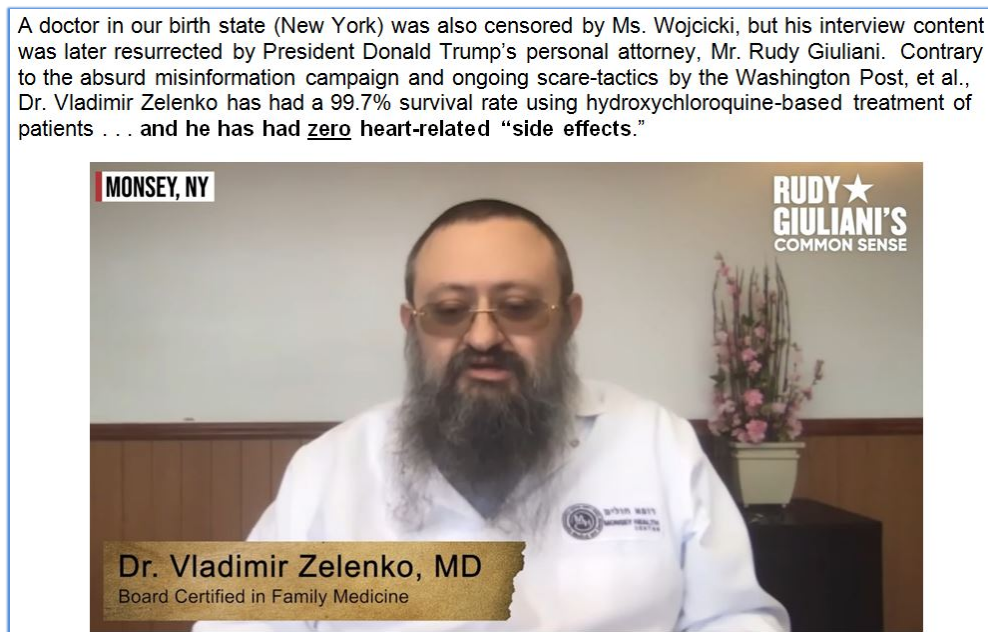
Subject 2: Connections of Weill-Cornell Medicine to the COVID-19 Nursing Homes Deaths

The virus asserted as the cause of COVID-19 resulted from illegal Gain of Function (GOF) research that occurred in-part in Communist China. This research was funded by both governmental and NGO groups; ranging from the NIH/NIAID to Google. The virus has been labeled as SARS-CoV-2.

SARS, severe acute respiratory syndrome, conveys that the malady is indicated by threats to the respiratory system; physiology **such as the lungs**. We return to that ironic, deeply disturbing detail on page 6 below.

At the very start of the pandemic, Dr. Zelenko was treating the life-threatening symptoms his patients were suffering, especially in the **lungs**. **The crux of his COVID-19 treatment protocol was, and remains, hydroxychloroquine.**

A full-year ago, July 2020, on page 5 of Reference 1 (screenshot):



In Reference 1 I estimated for Dr. Fauci the costs of non-vaccine treatment protocols; again, treatments that target a specific physiology: **the lungs**. Page 9 of Reference 1 discussed the work of Dr. Richard Bartlett:

The interview is focused on the treatment of the COVID-19 induced 'cytokine storms' in the lungs. His protocol involves nebulized Budesonide, vitamin supplements and anti-biotics. His success statistics are as good, or better than hydroxychloroquine. Similar to hydroxychloroquine costs, but unlike the billions of taxpayer dollars you have spent and continue to spend on vaccines, Dr. Bartlett's protocol is available now, and involves approximately \$100.

In her 20 June 2021 Sunday Morning Futures report, Maria Bartiromo stated:

"I was looking at a research report . . . Morgan-Stanley has estimated that Pfizer could earn \$100,000,000,000.00 from vaccines!"

Note, Maria's statement is not limited to Pfizer corporate-wide, her statement is not about revenue; her statement relates to profits from vaccines alone! With these non-vaccine treatment examples in mind, we examine the true priorities and stature of your NYC neighbor, Weill-Cornell Medicine.

Connections of Weill-Cornell Medicine to the COVID-19 Nursing Homes Deaths – con't

The dean of Weill-Cornell Medicine, Dr. Augustine M.K. Choi, also serves as the Provost for Medical Affairs for my alma mater, Cornell University. Both positions indicate that he has enormous direct effect on the practices and recommendations, within and outside the Cornell University community. The web page that discusses Dr. Choi's expertise (screenshot):

An internationally renowned physician-scientist in the field of lung disease,

Within walking distance of Choi's NYC office you find over *twenty* nursing homes wherein COVID-19 deaths occurred; not hundreds, but thousands died within earshot of Weill-Cornell Medicine. But cries for outpatient treatment to this "*renowned physician-scientist in the field of lung disease*" were not merely ignored, but actively derided. The horrors in the NYC nursing homes is evidentiary. Those horrors resulted from profiteering, driven by a "*vaccination is key*" operative, pushed by Cornell graduate Dr. Anthony Fauci and Weill-Cornell bureaucrat Dr. Augustine Choi:



During the entire COVID-19 pandemic I made numerous contacts with Dr. Choi and the Weill-Cornell staff. As one example, in July 2020 Dr. Choi signed-for *his* copy of Reference 1. That is, a full year ago, **Dr. Choi was placed on-notice** regarding the screenshots of Page 4 above; specifically the non-vaccine life-saving protocols being deployed to treat COVID-19 related lung disease . . . in the nursing homes.

While drafting *this* letter, I renewed a question with his staff, regarding the re-purposing of inexpensive drugs (versus the obscene profitability but unproven status of experimental mRNA "vaccines") :

"How many patients under the care of Weill-Cornell physicians have been treated for the symptoms of COVID-19 with either hydroxychloroquine or Ivermectin?"

Certainly I need not convey the consistency of the negative answers I received during prior and recent telephone calls. However, I did speak to the pharmacist, handled by Walgreen at Weill-Cornell. I was told:

I do not take-issue with the financial success of my alma mater; quite the contrary, I am a Cornell alum that had directly participated in those regards. **But I will not tolerate exploitation of the socially dependent, the fearful, or the ignorant (literally) as central to that success.** (Regarding the validity of those descriptors, please review the photograph at-right on Page 6 above.)

On this exploitation point, from your Sunday Morning Futures report (20 June 2021):

Maria Bartiromo: “ **So, does this boil down to money then Dr. Kory? I mean, this drug made by Merck, Ivermectin, is off-patent, they are not making any money on it anymore. But now, Fauci says he is looking at a drug that is going to be a patented drug, made by Merck. Are not the underlying chemicals the same, so now they are going to have that on patent, so that they can make a huge profit on it?! ” ***

Dr. Pierre Kory: “ I mean, that is so clearly a glaring example of the system that we are in. Which is, **for-profit medicines are favored to almost the total exclusion of non-profit medicines.** And so, you see, all of this money being thrown at pharmaceutical companies (Big Pharma) to develop new therapies, when we already have existing **re-purposed drugs** that are highly effective. A month prior to the Dr. Siegel “experimental” admissions, and just prior to firing over 150 dedicated Houston Methodist Hospital nurses and staff, **the bold-faced liar Mr. Boom** sent the following email to “every Houston Methodist employee and physician”:

From: Boom, Marc L., M.D.
Sent: Friday, May 28, 2021 2:56 PM
Subject: Lawsuit pending against Houston Methodist

Over the next few days, you may see media coverage on a lawsuit pending on behalf of 117 current and former Houston Methodist employees regarding our COVID-19 vaccine mandate, and I wanted you to hear about this from me first. It is unfortunate that the few remaining employees who refuse to get vaccinated and put our patients first are responding in this way. As of today, 99% of Houston Methodist's 26,000 employees have met the requirements for the vaccination mandate. We are extremely proud of all of you who have chosen to keep the patient at the center and have gotten vaccinated. As health care workers, it is our sacred obligation to do whatever we can to protect our patients, who are the most vulnerable in our community.

As we told the media, it is legal for health care institutions to mandate vaccines, as we have done with the flu vaccine since 2009. The COVID-19 vaccines have proven through rigorous trials to be very safe and effective and are not experimental. More than 165 million people in the U.S. alone have received vaccines against COVID-19, and this has resulted in the lowest numbers of infections in our country and in the Houston region in more than a year.

Thank you all for doing your part! Together we are fulfilling our mission of being the safest hospital system in the country. Please know you have my profound gratitude!

Note: This email was sent to every Houston Methodist employee and physician.

An eyewitness to the COVID-19 behaviorisms of Mr. Boom, and his for-profit hospital corporate ilk, was Ms. Jennifer Bridges, one of the nurses fired by him. Bridges explains:

“I had COVID last summer, I don't need that vaccine, and Methodist did not care about that, that was not an option at all.”

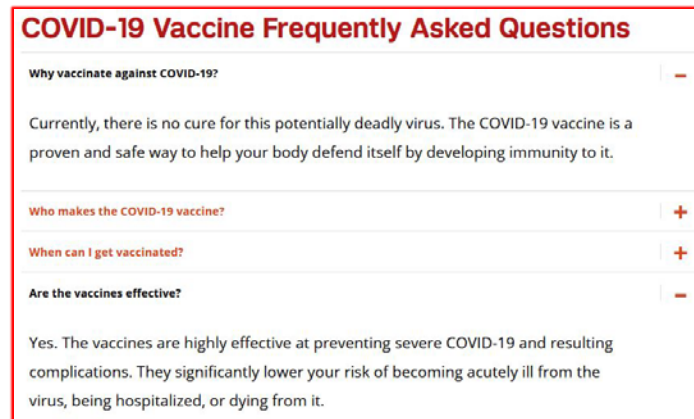

Lies of commission or omission at Houston Methodist Hospital and Weill-Cornell Medicine have caused the deaths of hundreds of thousands of Americans, **and tens-of-thousands in the nursing homes**. A screenshot from the Weill-Cornell Medicine COVID-19 Vaccine Information webpage:



Both expanded views display bold-faced lies. Regarding the first, it is well known to Mr. Boom and Dr. Choi that billions have contracted Dr. Fauci's SARS-CoV-2 GOF based virus, and completely recovered, without any treatments or "vaccinations" whatsoever. Therefore, for Boom and Choi to declare that the immune system of the human body (enjoyed by Ms. Bridges) is "no cure" or is *not* "proven," is an example of their **bold-faced, for-profit lies by commission**.

Regarding the second expanded view, we endure **for-profit lies by omission**. Let us paraphrase:

Are the *non-vaccine* treatments such as protocols that use hydroxychloroquine, Ivermectin, or budesonide effective?

Yes. These off-patent non-vaccine based protocols have been proven safe & highly effective, and on a world-wide basis, at preventing and permanently curing COVID-19 and any related complications. In fact, use of these treatments has proven to be so effective, that the year-long subversion of their use by the World Health Organization (WHO) is now the focus of a major lawsuit brought against WHO by the Indian Bar Association.

Conclusion

The harassment and dismissal of Ms. Ivory Hecker was based on the **“vaccination is key”** ignorance and personal opinions of Fox News clerks Ms. Lee Meier and Ms. Susan Schiller. In truth, Hecker never posted her personal opinions about the effectiveness of hydroxychloroquine; Hardly!

Likewise, neither did Fox News host Mr. Mark Levin while interviewing Yale Professor Dr. Harvey Risch, about hydroxychloroquine . . . all the way back in August 2020 . . . almost a full year prior to your ‘cease and desist’ dismissal of Ms. Hecker.

On Page 4 of Reference 5, I listed the salient portion of the August 2020 Levin/Risch interview (screenshot):



“Somehow we have let politics overrule science, and it is an absurd situation that people have compared to ‘1984’ and ‘The Ministry of Truth’ and so on; that is limiting what people can say on objective facts, it is beyond belief! . . . I think ‘they’ know the (hydroxychloroquine) treatment works. I think that basically they are afraid to even let it be tried, because letting it be tried would show

that it works. So the message has to be shut at all costs, because anything will leak out, and in fact it is leaking out, and you see across the country, people who started to speak up, who become almost deathly ill, and have been turned around in three days or sooner even, and these are now public figures who are speaking up, who have said that the medicine hydroxychloroquine saved their life. And it is very difficult to, you know, close all the leaks in that dike that are being suppressed by the media that are trying to do that.”

This has gone on before . . . now we have Dr. Fauci denying that any evidence exists of benefit, and that has pervaded the FDA. The FDA has relied on Dr. Fauci and his NIH advisory groups to make the statement saying that there is no benefit of using hydroxychloroquine in outpatients, and this is counter to the facts of the case. The (positive) evidence is overwhelming. The FDA has also said that there is harm in using these medications in outpatients (that) overweighs the benefits. Ninety per cent of the COVID cases have occurred since the FDA restricted (hydroxychloroquine usage) to inpatients-only. Dr. Fauci and the FDA are doing the same thing that was done in 1987, and that has led to the (COVID-19) deaths of hundreds of thousands of Americans that could have been saved by usage of this drug.

*This was started most noticeably in 1987 . . . **Seventeen-thousand people died because of Dr. Fauci’s insistence on not allowing even a statement supporting consideration of the use (of Bactrim vs. AIDS).**”*
