In the early 2021 timeframe, while Senator Peters was working his day-job (as a sales & marketing rep for a corporation he protects under **LIABILITY IMMUNITY**), his Democratic Party comrade in Lansing Michigan was **also** serving the interests of Pfizer . . . but with far more surreptitious duties :



Michigan Attorney General Nessel was coauthor and co-signatory of **Reference 1**; a Bolshevik-styled letter of 24 March 2021 to Twitter CEO Jack Dorsey and Facebook CEO Mark Zuckerberg. MEMORANDUM RULING ON REQUEST
FOR PRELIMINARY INJUNCTION

DEDUCTION: If Biden is a criminal, then so are the AGs of Reference 1; their censorship demand sent to Twitter/Facebook under the ruse of protecting us from “*vaccine disinformation.*”

Please note : My letter of 6 March 2023 (Reference 3) was distributed prior to the ruling by Judge Terry A. Doughty.

In my letter of 5 July 2023 to AG Andrew Bailey and AG Jeff Landry I declared (Reference 4) :

“ I am confident that AG Ellison, and the other eleven AG signatories . . . acted in-cooperation with the Biden White House. ”



The AGs who authored Reference 1 welcomed Biden’s hype, as did another group. Slithering in the shadows are the vested interests of Big Academia; the most insidious of the global COVID-19 crime syndicate. Their legal concerns are borne in-part by the blatant criminality of their vaccine mandates; the criminality of Big Academia is directly connected to Subject 1 : Mrs. Jummai Nache.

A University of Minnesota Medical Assistant, Mrs. Nache assumed the integrity of her state attorney general, Mr. Keith Ellison. She was unaware that AG Ellison was directly involved in subverting her First Amendment rights; **she was unaware of Reference 1.** She was unaware that AG Ellison had secretly blocked access to crucial COVID-19 medicinal and therapeutic information :

In lockstep with Missouri et al. versus Biden (Reference 2), the AG censorship involved not merely the demeaning of qualified/accredited health information as “misinformation” or “disinformation,” but threats against those demanding their First Amendment. **The existing censorship, later officialiated by the AGs of Reference 1, was being carried out by unqualified Twitter/Facebook trolls.** What was one result?

The “mRNA vaccine” profiteers, media gatekeepers, and the AGs of Reference 1 are directly connected to Subject 1 . . . **a horror that the First Amendment was implicitly designed to thwart . . . a horror which befell a trusting but perhaps naive human being : Mrs. Jummai Nache.**

Prior to the dates on the CDC COVID-19 Vaccination Record Card, Mrs. Nache was a “model of health.” A lifetime non-smoker, non-drinker, mother and wife; Mrs. Nache devoted her salary, earned as a **UMinn** medical assistant, to family and household. Despite her hospital workplace environment, spanning 2019, 2020 and early 2021, she never had a runny nose; never-mind full blown “*symptoms of COVID.*”

That all ended on the evening of “2/1/21.”

After much haggling, Mr. Philip Nache received an unredacted copy of his wife’s UMinn medical record. UMinn expects submission to their dismissal posturings. While hiding behind **LIABILITY IMMUNITY** (provided by Anthony Fauci, and the 2019 servility of President Donald Trump); it was in that context only that UMinn experts had a brief encounter with basic integrity :

“Again discussing”?!

“Potential role of the vaccine”?!

“Though it can’t be excluded”?!

“Contributing to some extent”?!

The following portion of the UMinn medical report was filed **prior** to the thromboembolism-based amputation horrors inflicted upon Mrs. Jummai Nache (Note their scurrying to **“the letter from the CDC”**) :

Assessment:

Jummai P Nache is a 50 year old female patient who is following up after a prolonged admission and continued rehab after MIS-A. Her clinical course has left her with life-changing physical disfigurement which is almost certainly going to need amputation.

Most of our visit was spent again discussing the potential role of the vaccine in this process. Dr. Fontana shared the letter from the CDC stating that this was MIS-A without clear involvement from the vaccine, though it can't (and likely never will be) excluded as contributing to some extent. Since the last visit, and separate from the laboratory evidence discussed with the CDC, I did have the PF4 antibody testing done on a blood sample saved from around the same day as her arterial thrombotic events. This testing was negative. Thrombotic Thrombocytopenic Syndrome (TTS, previously termed VITT as mentioned in my previous note) is the syndrome linked to the infrequent CSVT and other thrombotic events linked to Johnson and Johnson vaccines. While we do not have pathognomonic tests for this (or most other disorders), the PF-4 antibody testing is quite sensitive, so the absence of it is reassuring against that diagnosis. Greinacher et al. **Thrombotic Thrombocytopenia after ChAdOx1 nCov-19 Vaccination**, *NEJM* April 2021 <https://www.nejm.org/doi/full/10.1056/NEJMoa2104840>). The onset here was also a bit early, based on discussions I had with an expert on the topic at another institution in reviewing this case.

We spent 45 minutes reviewing what constitutes MIS-A versus other similar inflammatory or infectious states, how the vaccine could have hypothetically amplified an MIS-A that might have occurred anyway, but since we do not know why some are susceptible to MIS and not others, we cannot even say that for sure. My feeling is that they are still in the coping phases of this, and more will come with the amputations needed, so I am just trying to support Jummai and Phillip through this with as much evidence-based background to Jummai's events as I can. I will keep working with them to help provide ongoing feedback for their MIS- and clot-related questions.

The above (from Page 183 of 1164) is part of the 21 May 2021 entry by UMinn Dr. Alexander A. Boucher :

“Most of our visit was spent again discussing the potential role of the vaccine in this process. Dr. Fontana shared the letter from the CDC stating that this was MIS-A without clear involvement from the vaccine, though it can't (and likely never will be) excluded as contributing to some extent.”

The National Cancer Institute, part of the National Institutes of Health, **still** defines COVID-19 as follows :

NIH NATIONAL CANCER INSTITUTE

A highly contagious respiratory disease caused by the SARS-CoV-2 virus. SARS-CoV-2 is thought to spread from person to person through droplets released when an infected person coughs, sneezes, or talks. It may also be spread by touching a surface with the virus on it and then touching one's mouth, nose, or eyes, but this is less common. The most common signs and symptoms of COVID-19 are fever, cough, and trouble breathing. Fatigue, muscle pain, chills, headache, sore throat, runny nose, nausea or vomiting, diarrhea, and a loss of taste or smell may also occur. The signs and symptoms may be mild or severe and usually appear 2 to 14 days after exposure to the SARS-CoV-2 virus. Some people may not have any symptoms but are still able to spread the virus. Most people with COVID-19 recover without needing special treatment.

SARS-CoV-2? SARS, Severe Acute Respiratory Syndrome, induces a respiratory illness. But in early 2021 the UMinn doctors are *already* reporting : “*clot related questions*” ?!

Memo to Congresswoman Luna : Please share with St. Petersburg, Florida resident Ms. Claire Bridges. She was “vaccinated” with modRNA, but like Mrs. Nache she later tested positive anyway, and then like Mrs. Nache lost both legs due to what doctors dismissed as “*complications from COVID-19.*”

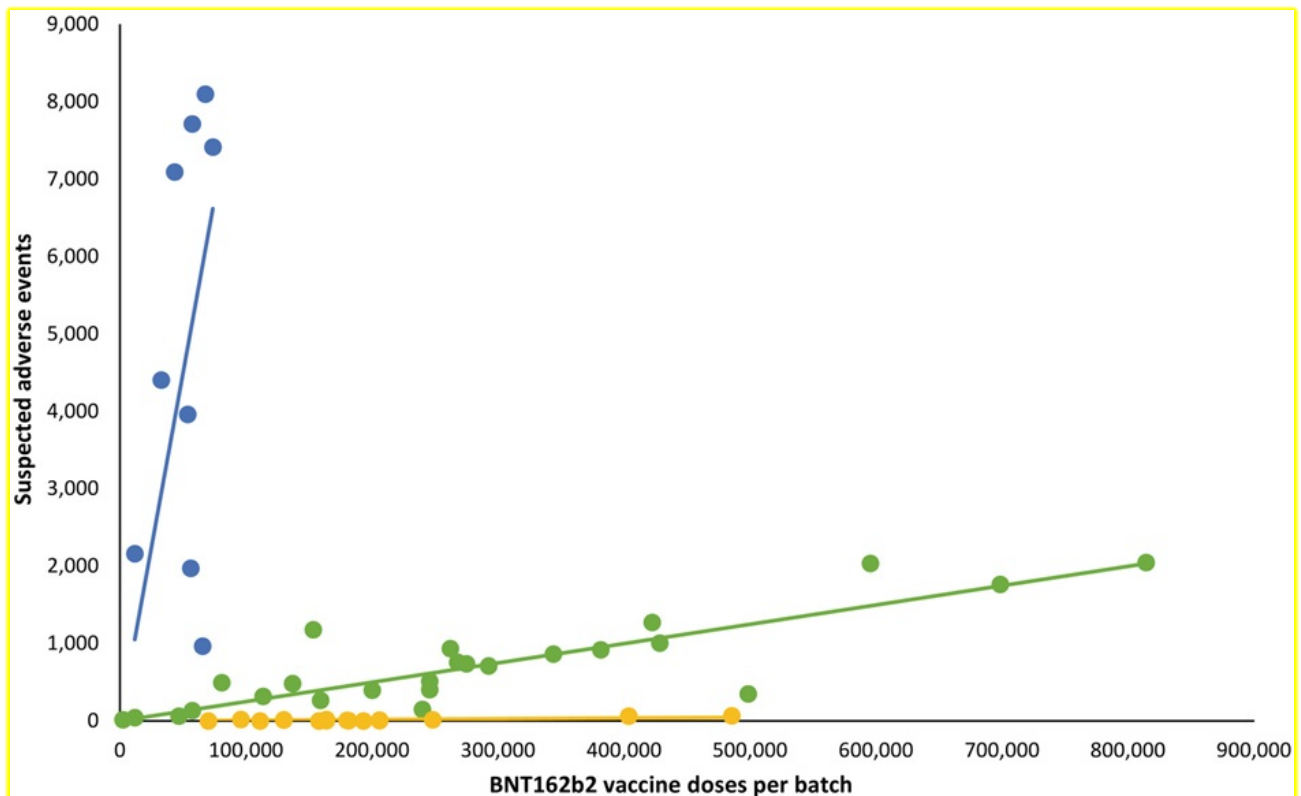

“discarded.”

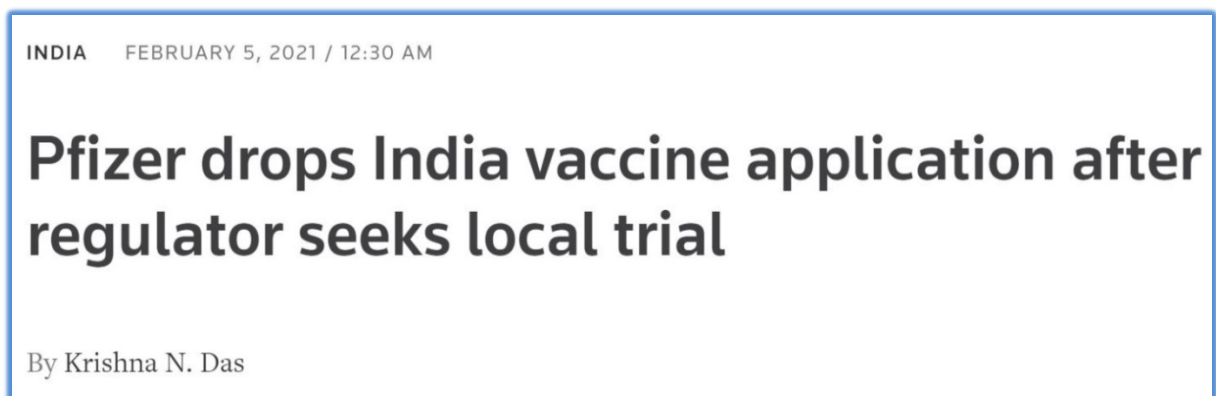

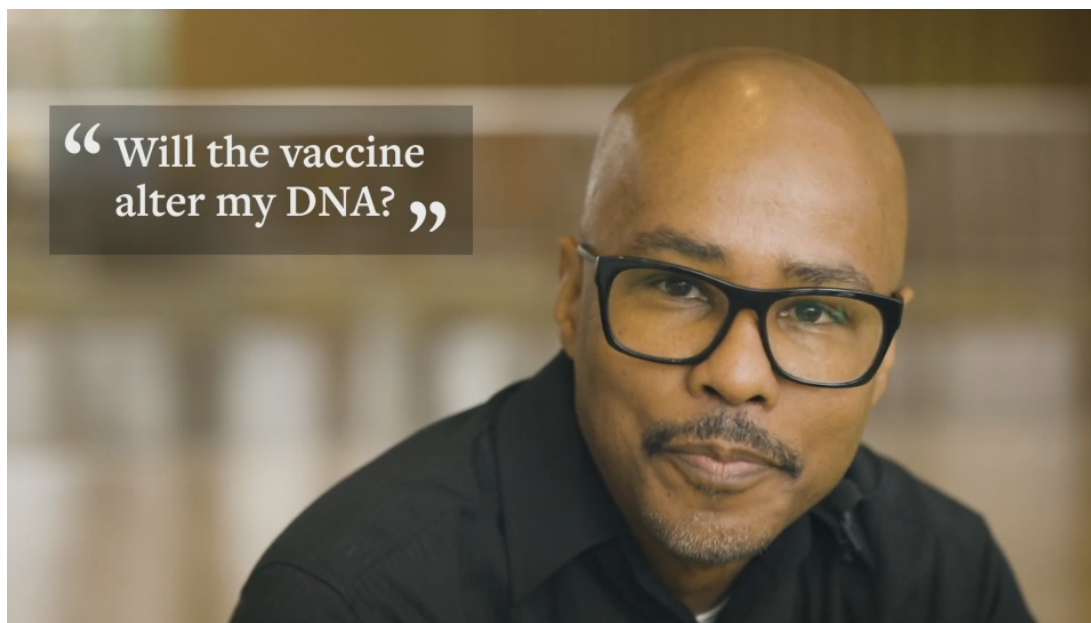

The above video was posted on 5 April 2021 (?!); not just at the Cornell website, but at YouTube, Vimeo, BitChute, Instagram, Twitter, Facebook, and even overseas sites where language captions were provided.

Almost NOTHING in the cheerleading is accurate. In terms of the real-world data available in early 2021, **and similar to Reference 1, the essence of the August response is, at-best, baseless.**

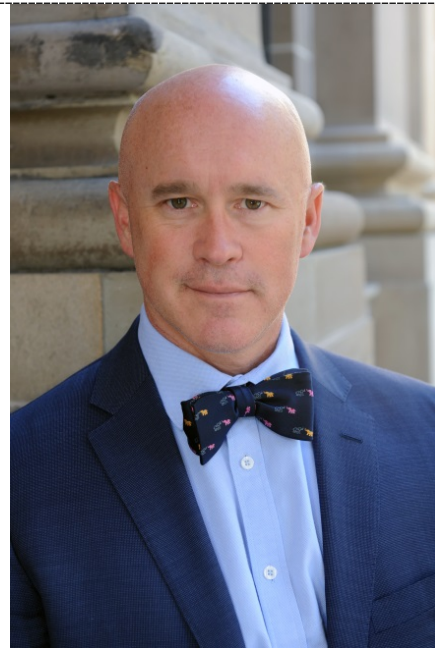

Dear Messrs. Dorsey and Zuckerberg:

As Attorneys General committed to protecting the safety and well-being of the residents of our states, we write to express our concern about the use of your platforms to spread fraudulent information about coronavirus vaccines and to seek your cooperation in curtailing the dissemination of such information. The people and groups spreading falsehoods and misleading Americans about the safety of coronavirus vaccines are threatening the health of our communities, slowing progress in getting our residents protected from the virus, and undermining economic recovery in our states.

As safe and effective vaccines become available, the end of this pandemic is in sight. This end, however, depends on the widespread acceptance of these vaccines as safe and effective. Unfortunately, misinformation disseminated via your platforms has increased vaccine hesitancy, which will slow economic recovery and, more importantly, ultimately cause even more unnecessary deaths. A small group of individuals use your platforms to downplay the dangers of COVID-19 and spread misinformation about the safety of vaccines. These individuals lack medical expertise and are often motivated by financial interests. According to a recent report by the Center for Countering Digital Hate¹, so-called “anti-vaxxer” accounts on Facebook, YouTube, Instagram, and Twitter reach more than 59 million followers. “Anti-vaxxers” are using social media platforms to target people of color and Black Americans specifically, members of communities who have suffered the worst health impacts of the virus and whose vaccination rates are lagging.

Given “anti-vaxxers” reliance on your platforms, you are uniquely positioned to prevent the spread of misinformation about coronavirus vaccines that poses a direct threat to the health and safety of millions of Americans in our states and that will prolong our road to recovery.

The updated community guidelines you have established to prevent the spread of vaccine misinformation appear to be a step in the right direction. However, it is apparent that Facebook has not taken sufficient action to identify violations and enforce these guidelines by removing and labelling misinformation and banning repeat offenders. As a result, anti-vaccine misinformation continues to spread on your platforms, in violation of your community standards.

- Twitter and Facebook have yet to remove from all their platforms the accounts of prominent “anti-vaxxers” who have repeatedly violated the companies’ terms of service. Digital media research groups estimate that as of March 10, 12 “anti-vaxxers” personal accounts and their associated organizations, groups and websites are responsible for 65% of public anti-vaccine content on Facebook, Instagram, and Twitter.
- Facebook has failed to consistently apply misinformation labels and popups on Facebook pages and groups that discuss vaccines or COVID-19. For example, the company neglected to apply warning labels on dozens of Facebook groups that “anti-vaxxer” Larry Cook created for his followers. At the same time, the company has mistakenly flagged pro-vaccine pages and content in ways that have undermined pro-vaccine public education efforts.
- Facebook has allowed anti-vaxxers to skirt its policy of removing misinformation that health experts have debunked, by failing to prevent them from using video and streaming tools like Facebook Live and sites like Bitchute, Rumble, and Brighteon to evade detection.

We call on you to take immediate steps to fully enforce your companies’ guidelines against vaccine misinformation. By effectively rooting out fraudulent information about coronavirus vaccines, you can prevent needless illness and death and hasten our road to recovery.

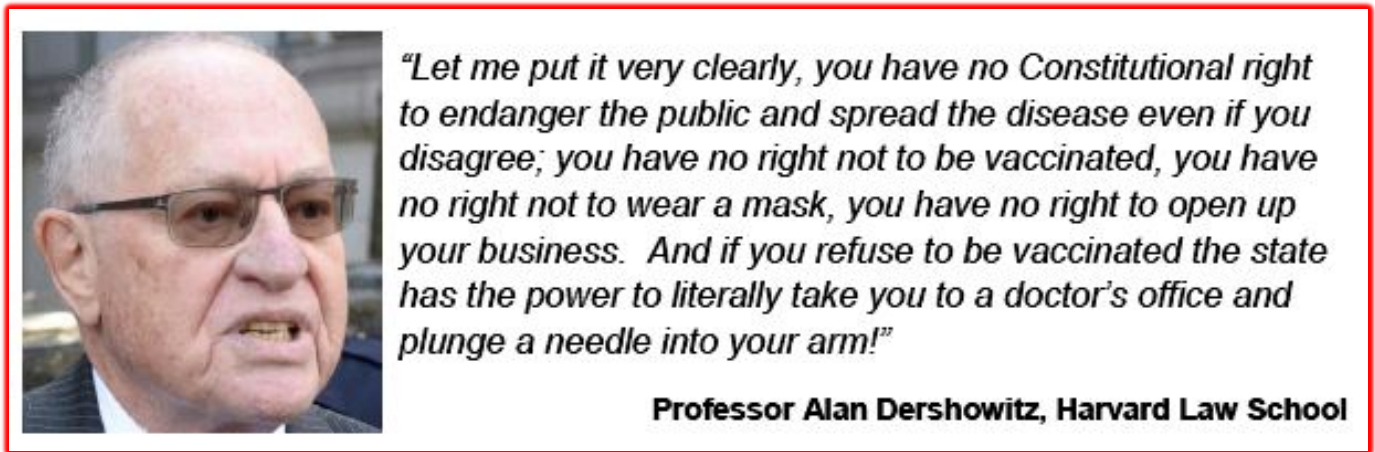

True to form, the authors could not even write its Summary without immediately resorting to lies by commission and omission; their very first sentence reads:

“Viruses that replicate in the human respiratory mucosa without infecting systemically, including influenza A, SARS-CoV-2, endemic coronaviruses, RSV, and many other ‘common cold’ viruses, cause significant mortality and morbidity and are important public health concerns.”

Assuming we were all born-yesterday, the authors gloss over their not-so-subtle stampede; that influenza A and SARS-CoV-2 are of the same natural origin, of similar structure, similar infection pathways. This paper was authored prior to the recent Department of Energy study that confirms, what casual observers have known since late 2019: **SARS-CoV-2 was not developed by Chinese bats that frequent fish markets:**



The ReThinking Summary continues:

“Because these viruses generally do not elicit complete and durable protective immunity by themselves, they have not to date been effectively controlled by licensed or experimental vaccines.”

“Viruses . . . not to date effectively controlled by licensed or experimental vaccines” ?! Such as SARS-CoV-2? Now, after three years of horror induced by their “science,” are the authors forcefully but **preemptively** declaring the opposite? There were ten cases of severe disease, one in the vaccine, nine in the placebo. For the Moderna trial, it was 94.5% efficacious. Eleven severe events, zero in the vaccine, eleven in the placebo.

For those of you not acquainted with the field of vaccinology, that is extraordinary. That is almost to the level of what we see with measles, which is 98% effective. So that’s what we’re dealing with.

*I used the word ‘efficacious.’ The means what happens in a clinical trial. The word ‘effective’ means, is what the ultimate impact of that vaccine is gonna have on society. **And the only way you can get an effective program is when the people take the vaccine.**”*

Adolescent Backpedaling by “Doctor Science” and COVID Colleagues Con’t

Re-read that closing paragraph by Doctor Science. He spoon-feeds the Pfizer marketing staff (White House press corps) about the statistical terms efficacious versus effective. He mumbled :

“And the only way you can get an effective program is when the people take the vaccine.”

Trite, but only in appearance. We are dealing with Anthony Fauci; a person that Cornell University Professor of Chemistry, Dr. David Collum, described in a widely publicized interview of 3 August 2021 :

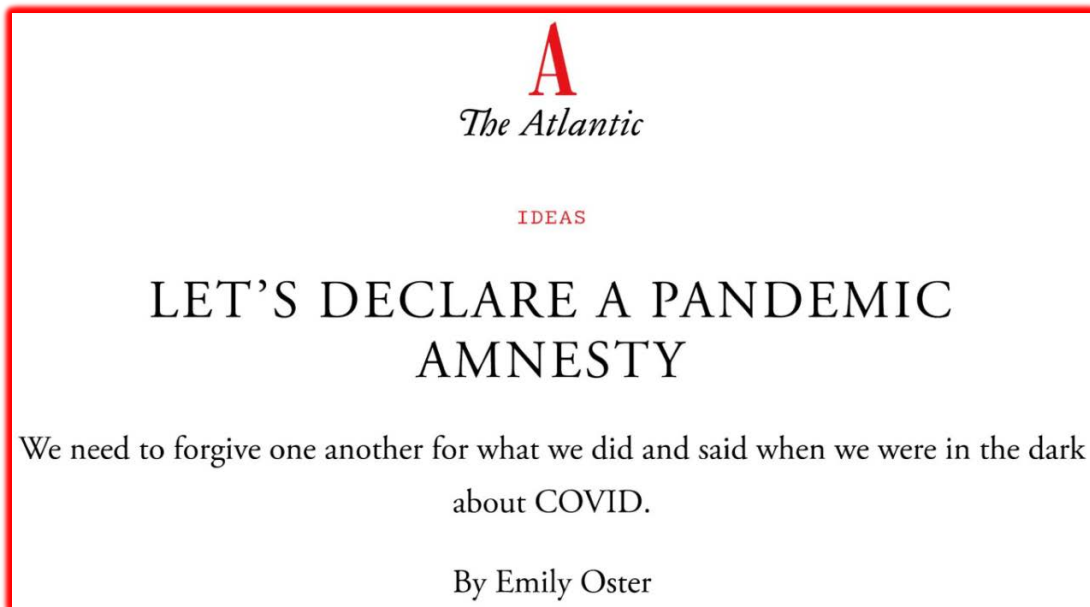

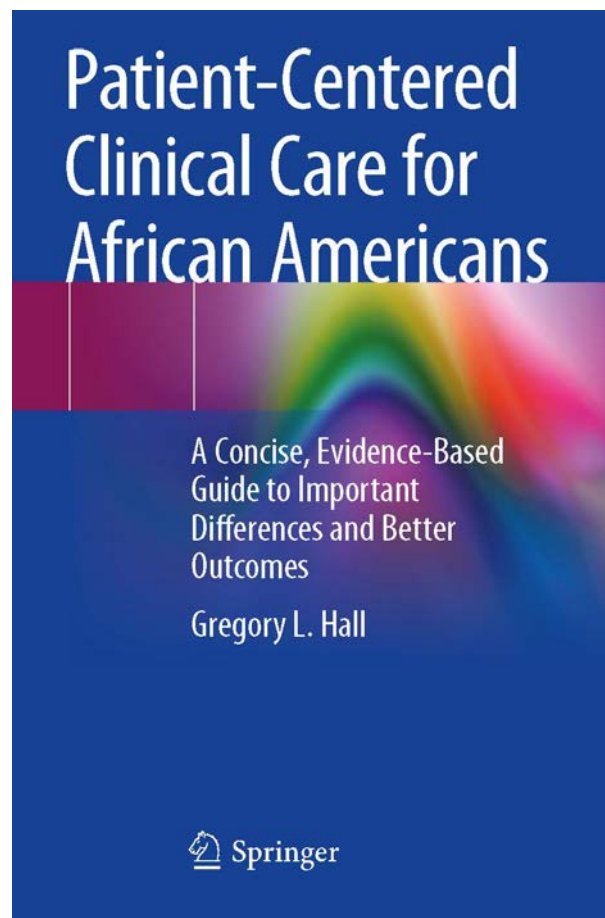
Conclusion

The **“letter of 12 May 2023 addressed to rPOTUS”** is instant Reference 2; I have enclosed a duplicate for your Washington Field Office file. Reference 1 presupposes your assessment that I do not pose **“a serious threat to rPOTUS.”** If the organization you (now) lead was sincerely concerned in that regard, they would have had, and continue to have, an **“open file”** on the following individuals . . . 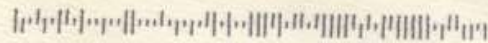

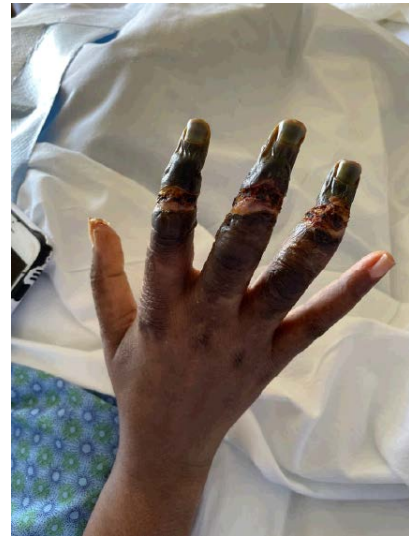
