**Dear Governor Walz :**


On *many* occasions I have presented my opinion regarding the 2024 presidential candidacy of Mr. Donald Trump :

Page 3 of Reference 1 displays a signature that you directed and approved as governor :

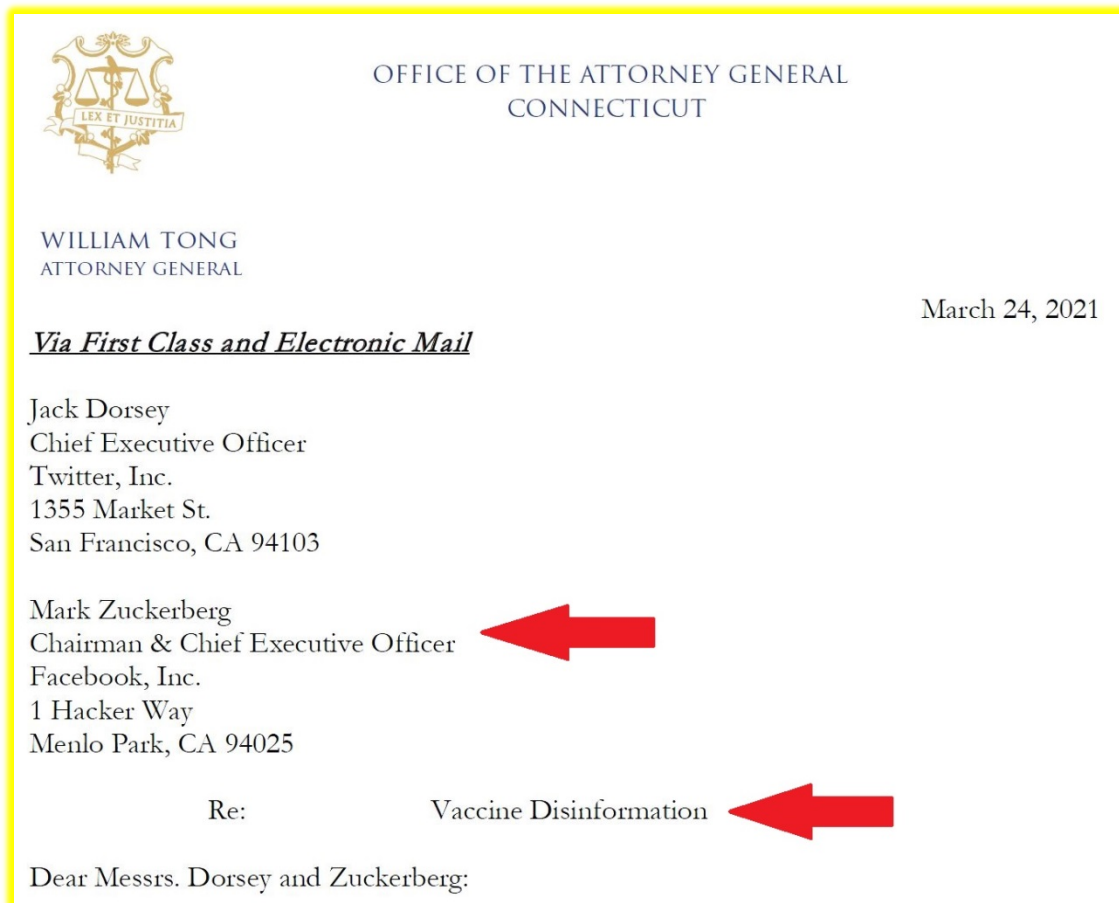

Further, to the extent applicable, Purchaser acknowledges that the Product shall not be serialized.

**“Purchaser further acknowledges that the long-term effects and efficacy of the Vaccine are not currently known” ??? “There may be adverse effects” ??? Is this what was publically asserted to America?**

The signing of that supply contract was March 30 2021 . . . **a mere six days after Reference 1.**

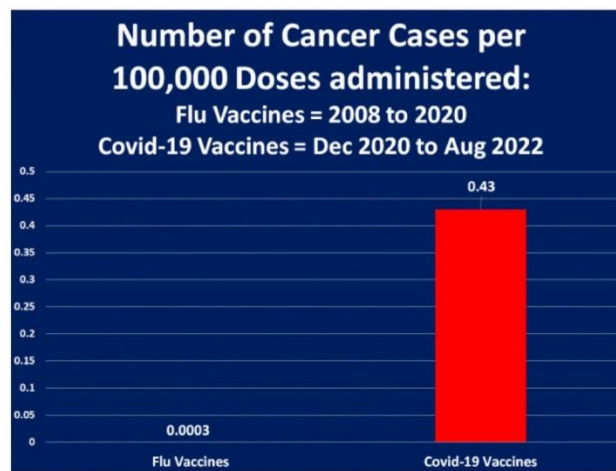

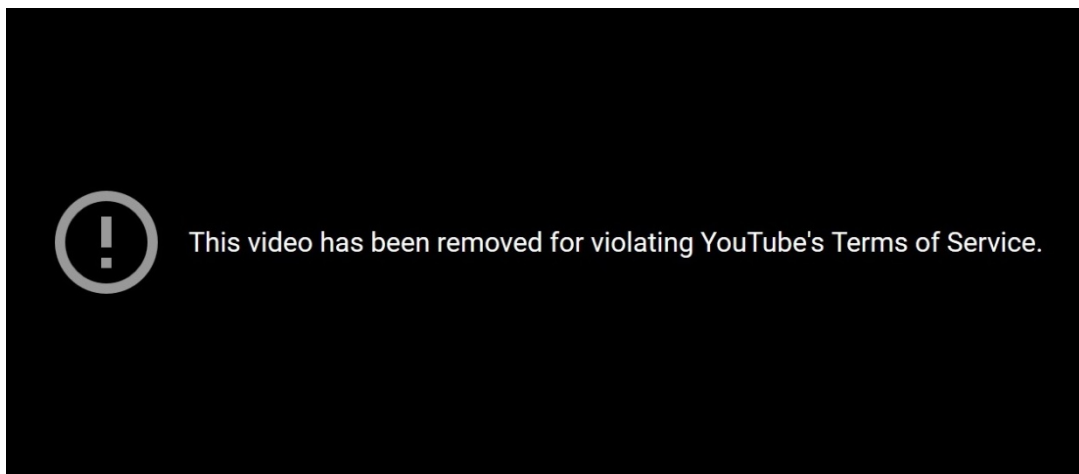
