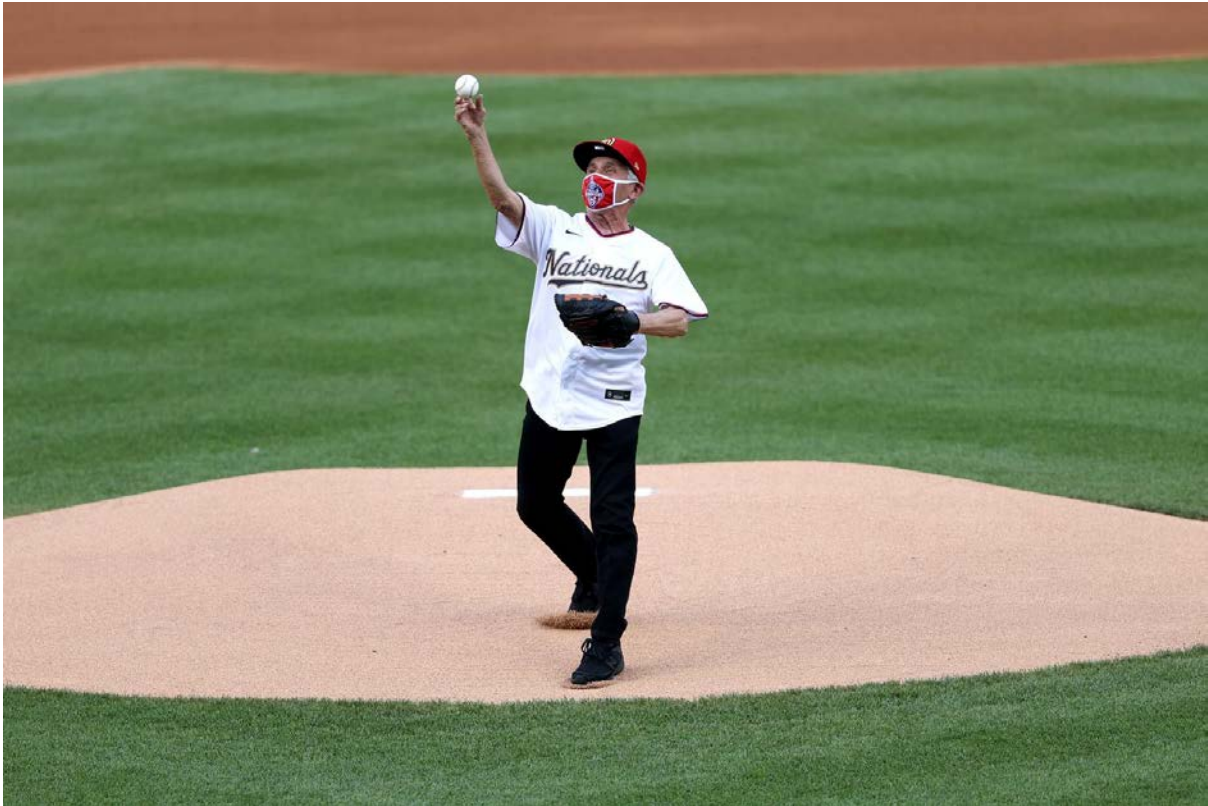

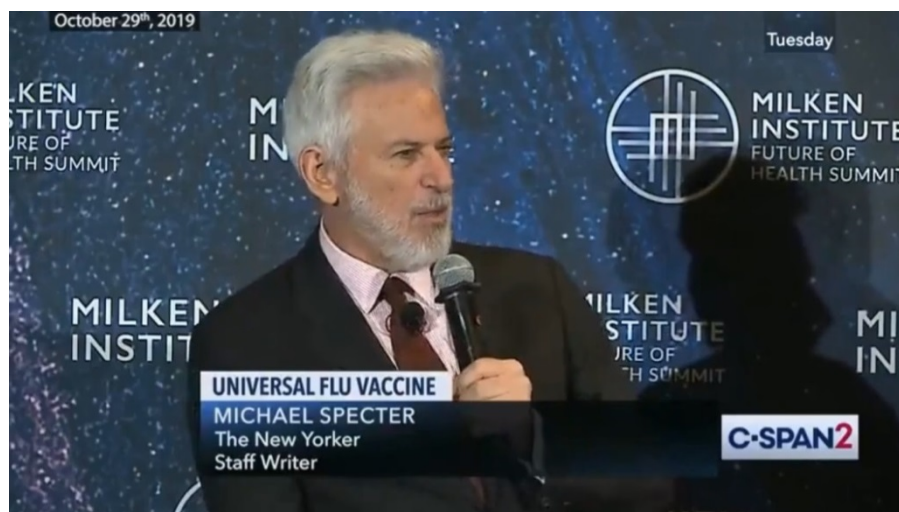

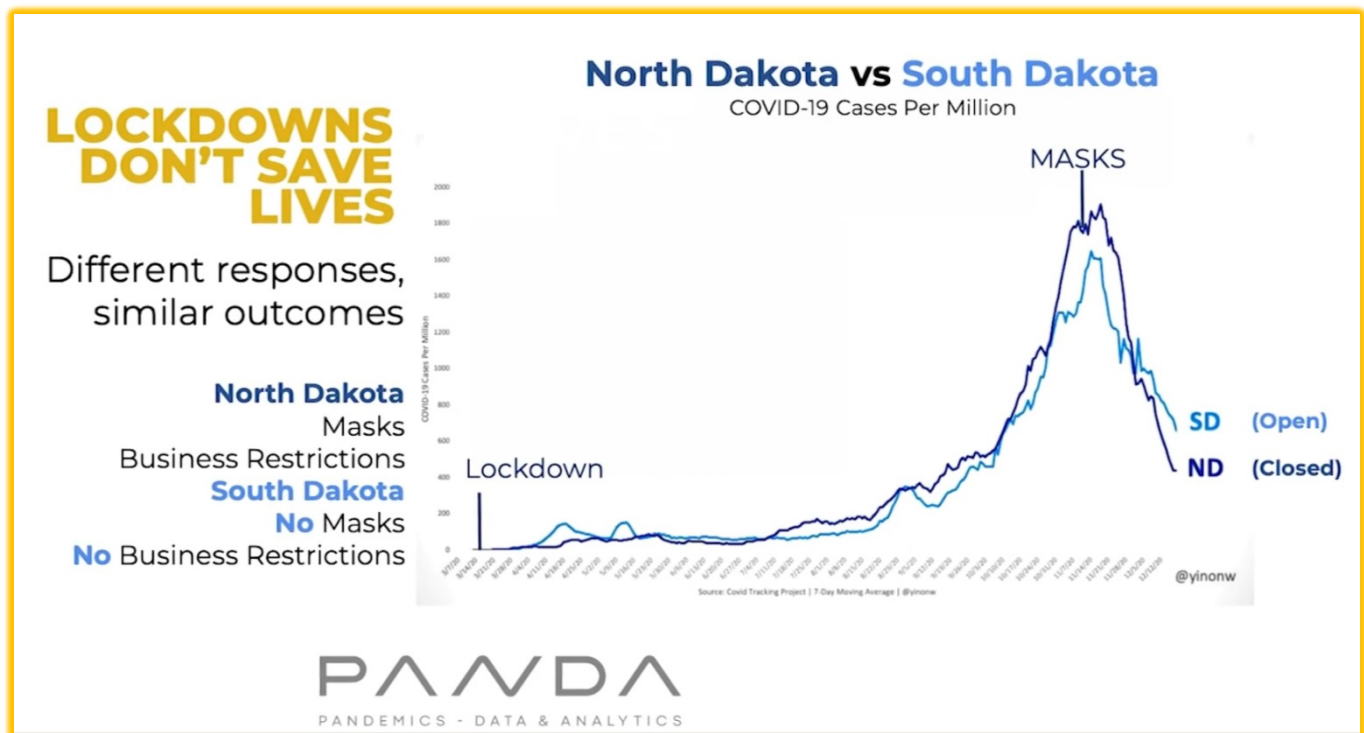

At the White House Governors Working Session of February 21 2025, the President reviewed his Executive Order, *KEEPING MEN OUT OF WOMEN'S SPORTS* (February 5 2025).



Maine Governor Ms. Janet Mills was asked directly, and politely, if she intended to comply with that executive order. With predictable inaccuracy Ms. Mills snidely blurted :

“I’m complying with state and federal laws.”

Is her outburst even remotely true? Is she duplicitous?

When the President asserted the obvious, that federal law *is* established by Executive Order, and that non-compliance would jeopardize **federal funding**, Ms. Mills threatened the President :

“See you in court!”

Does Ms. Mills have a history of complying with federal law? Or is her compliance restricted to issues that suit the agendas of her anti-Trump allies? Does she have experience with the relationship between compliance with federal law and federal funding?

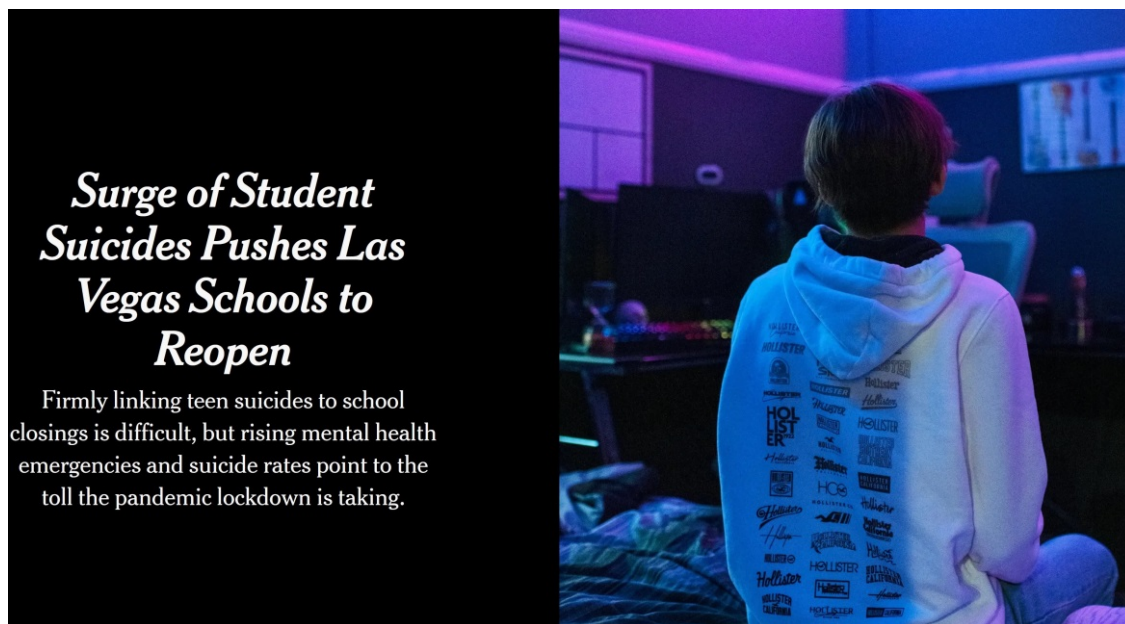

Throughout 2020, data was widely available confirming an increase in youth suicides, which was scientifically connectable to school closures. On March 15 2020 Ms. Mills declared a COVID-19 'state of emergency' . . . specifically because it ***“allows the state to access federal funding and allows for suspension of certain laws.”***⁷ Contrary to her duplicative outbursts at the White House, when she supports an agenda she has no problem submitting to the conditional relationship between compliance with federal law and federal funding.

That the **increase** in youth suicide was connectable to school closings is undeniable. But that did not stop the propagandists at the New York Times from spewing the exact opposite :



The byline, ***“Firmly linking teen suicides to school closings is difficult”***!? That NYT article was published on January 24 2021. But in December 2020 it was **already** widely-disseminated that the December 4 suicide note of 16-Year-old Spencer Smith specifically pointed to the Maine lockdowns as the basis of his decision. Difficult ?!

In mid 2020, Dr. Robert Redfield of the CDC had already connected school closings to an increase in child suicides; that (K-thru-12) closures posed a ***“substantial public health negative consequence.”*** Regardless of that quote, six months later the New York Times was still lying, babbling that the school closure / suicide connection was “difficult.”^{8 9}

Again, does Ms. Mills have prior direct experience with the conditional relationship between federal law and **federal funding**? She not only touts experience with the more strident federal laws, her history includes a groveling compliance with mere “health guidance” from globalists !

The COVID-19 Crime Syndicate had **schemed** “health guidance” compliance as conditional to federal funding. That scheme was central to the modRNA mandates. ¹⁰

In 2020/2021 Ms. Mills was *notoriously* enforcing the COVID-19 schemes. Indeed she had no reservations when ignoring the real world consequences of her school closures; such as prior documented prognostications that Maine youth would resultantly be at an increased risk of suicide. Given that federal funding was tied to those closures, the reality of increased suicide risk had no mitigating effect on her lockdown tyranny.

In stark contrast, unlike her self-righteous behavior at the White House, when her 2020/2021 compliance with “health guidance” was in blatant violation of the United States Constitution, she never stood up in defense of the citizens of Maine . . . and she certainly never blurted :

“I’m complying with state and federal laws.” ¹¹

In December 2020, I presented to Governor Mills the relevant Maine state law : **The Child and Family Services and Child Protection Act** . . . a screenshot from my Reference 1, Page 18 :

Title 22, Subtitle 3, Part 3, Chapter 1071 is entitled: Child and Family Services and Child Protection Act. Subchapter 1, [Section 4002](#) provides definitions:

Paragraph 1 is entitled: Abuse or neglect.

Abuse or neglect means a threat to a child's health or welfare by physical, mental or emotional injury or impairment, sexual abuse or exploitation including under . . . deprivation of essential needs or lack of protection from these or failure to ensure compliance with school attendance requirements . . . by a person responsible for the child.

Paragraph 1C is entitled: Best interest of the child.

Paragraph 2 is entitled Child:

Child means any person who is less than 18 years of age.

Paragraph 5 is entitled: Custodian.

Custodian means the person who has legal custody and power over the person of a child.

Is Ms. Mills going to argue that her *“abuse or neglect”* is not connectable to the Subject?

Is Ms. Mills going to argue that her school closures did *not* constitute *“a threat to (Spencer’s) health or welfare by physical, mental or emotional injury or impairment . . . including . . . failure to ensure compliance with school attendance”*!?

Is Ms. Mills going to argue that her actions were *“in the best interest of (Spencer)”* ?

Is Ms. Mills going to argue that her actions as Governor of Maine she did *not* assert her *“legal custody and power over the person of a child (Spencer)”* ?

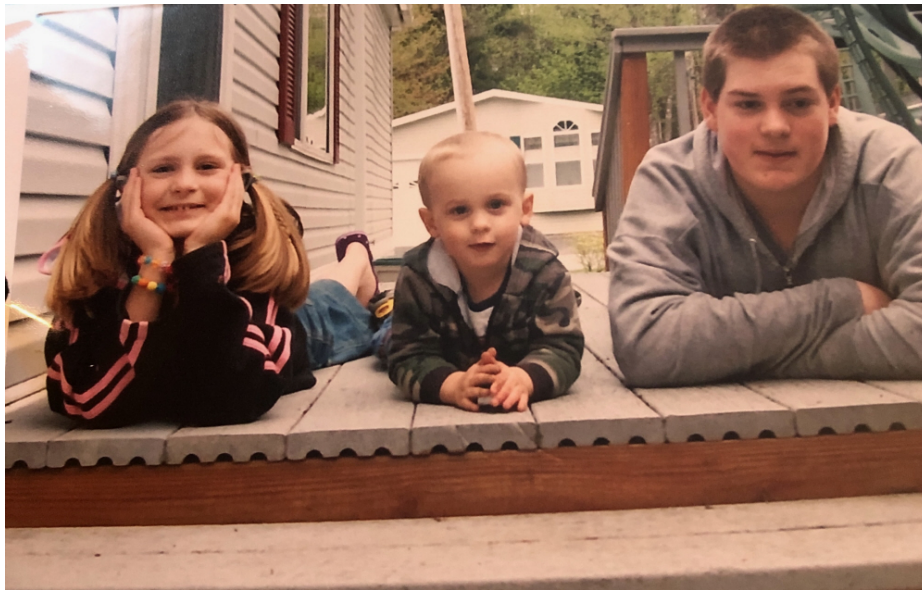

We review the Gross Criminal Negligence (GCN) law:

“Gross negligence is culpable or criminal when accompanied by acts of commission or omission of a wanton or willful nature, showing a reckless or indifferent disregard of the rights of others, under circumstances reasonably calculated to produce injury, or which make it not improbable that injury will be occasioned, and the offender knows or is charged with knowledge of the probable result of his/her acts; ‘culpable’ meaning deserving of blame or censure.”

You are aware that I had discussed this issue, regarding your person, with the now-confirmed treasonous US Attorney General Mr. William P. Barr on 28 August 2020 (Attachment 1).

Consistent with historical and ongoing behavior, **and contrary to your self-effacing crap about “speaking the truth at all times,”** you failed to offer the courtesy of a response:

Your Two Most Prominent Lies - How These Led to the Death of Mr. Spencer William Smith

We are now beyond the ten items discussed in Attachment 2. In this communication, we now focus on your two most prominent lies / frauds:

1. Your lie that the only way the United States can attain “herd immunity” is through vaccination; attained at a market share of “75%” (your baseless statistical claim).
2. Your bold-faced lie that the PCR process can be modified through “amplification,” and *then* deployed world-wide as the “gold standard” (for detection of what has been labeled SARS-CoV-2) for determination of COVID-19 infection.

That quote above from Dr. Mullis (pictured with the Dr. Peter Duesberg epic [Inventing the AIDS Virus](#)), provides a truer perspective on your television claim to the Financial Times of London:

“I have a reputation, as you probably have figured out, of speaking the truth at all times and not sugar-coating things. And that may be one of the reasons why I haven’t been on television very much lately.”

Relating to the late-1980’s work of Dr. Duesberg, and your ongoing pandemic resume, I quoted renown Yale professor Dr. Harvey Risch on pages 7-8 of Attachment 1:

“Somehow we have let politics overrule science, and it is an absurd situation that people have compared to ‘1984’ and ‘The Ministry of Truth’ and so on; that is limiting what people can say on objective facts, it is beyond belief ! . . . I think ‘they’ know the (hydroxychloroquine) treatment works. I think that basically they are afraid to even let it be tried, because letting it be tried would show that it works. 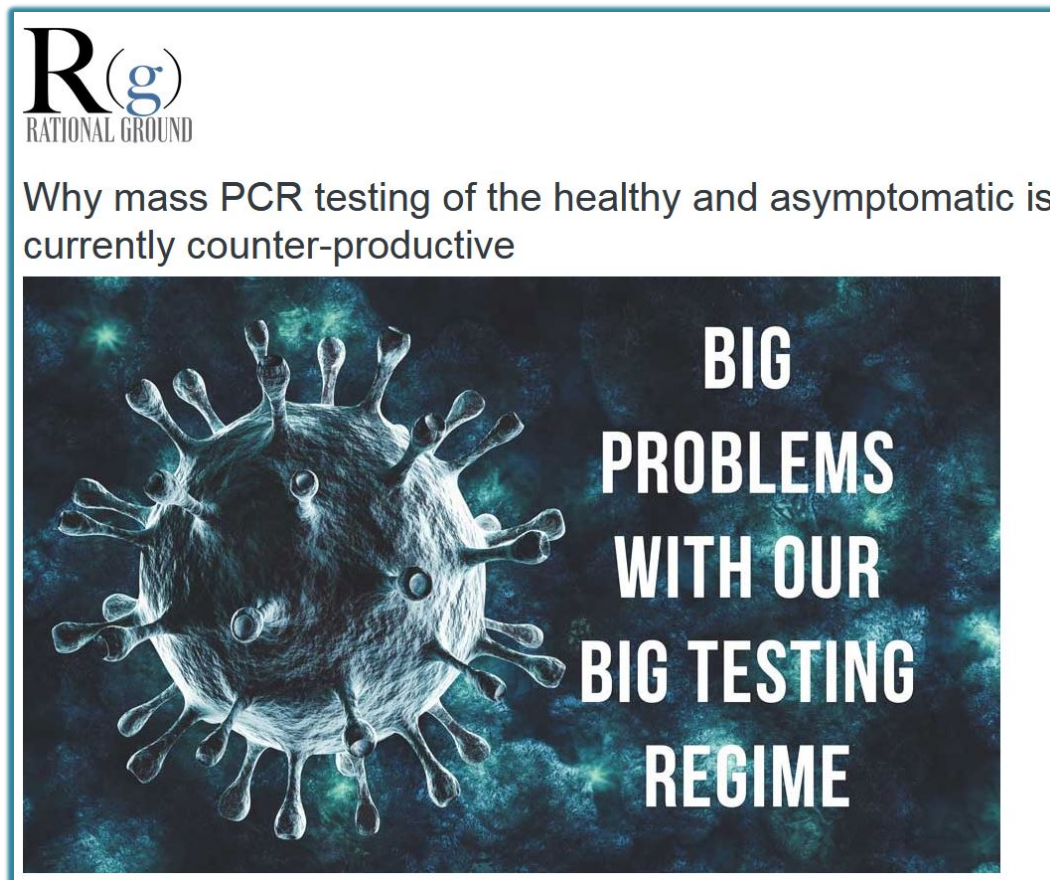

The Verisimilitude of Governor Janet Mills – Her Crime of Child Abuse

The legislature of Maine oversees, under the Year 2013 Arraignment of the Maine State Constitution, **laws to protect the children of Maine from ‘child abuse.’**

Title 22, Subtitle 3, Part 3, Chapter 1071 is entitled: Child and Family Services and Child Protection Act. Subchapter 1, [Section 4002](#) provides definitions:

Paragraph 1 is entitled: Abuse or neglect.

Abuse or neglect means a threat to a child's health or welfare by physical, mental or emotional injury or impairment, sexual abuse or exploitation including under . . . deprivation of essential needs or lack of protection from these or failure to ensure compliance with school attendance requirements . . . by a person responsible for the child.

Paragraph 1C is entitled: Best interest of the child.

Paragraph 2 is entitled Child:

Child means any person who is less than 18 years of age.

Paragraph 5 is entitled: Custodian.

Custodian means the person who has legal custody and power over the person of a child.

These are a few of the relevant portions of the Maine Statute on Child Abuse. We therefore ask:

Is there any doubt that 16-year-old Spencer William Smith was a child? Is there any doubt that Dr. Anthony Fauci and Governor Janet Mills were in-effect custodians, and in that context exacted their “power over the person of a child” ? Is there any doubt that the ‘Best Interest’ of Spencer was severely neglected by Dr. Fauci and Governor Mills ? Is there any doubt that Dr. Fauci and Governor Mills consciously failed “to ensure compliance with school attendance requirements” ? (see quote Page 20 of 21 below).

ORU President Dr. William Wilson announces a return to normal operations at ORU.



- ▶ Students will not be required to have a vaccination for COVID-19 in order to attend ORU this Fall. We have not been requiring, nor will we require, COVID-19 vaccinations of staff or faculty in order to serve or work at this university.
- ▶ Students will not be required to test for COVID-19 before entering the dorms.
- ▶ Masks will be optional in all campus venues and at all campus events. They will not be required anywhere on campus.
- ▶ Our cafeteria, food outlets, Chapel, classrooms and all departments will return to normal operations without social distancing. Classroom sizes will return to normal, and we will have normal student-faculty interactions.
- ▶ There will be no temperature checks and no check-in apps when you come onto campus this Fall.
- ▶ All residential classes will continue to be taught in-person, face-to-face and virtually.
- ▶ We will maintain quarantine and isolation space should we need them.
- ▶ Testing for COVID-19 and the influenza virus will be available to staff, faculty and students free of charge, allowing anyone who is symptomatic to be tested.
- ▶ We will maintain our hand sanitizing stations on campus to ensure good hygiene.
