Subject : **Your True “Contribution” and True Legacy of Inflicting Embarrassment, Inveracity and Criminality Upon My Alma Mater - Cornell University**

“95% safe & effective”?! The Supply Contract ‘Purchaser Acknowledgement’ was well-known to you Ms. Pollack; you were directly connected to Mr. Bourla throughout 2020/2021:

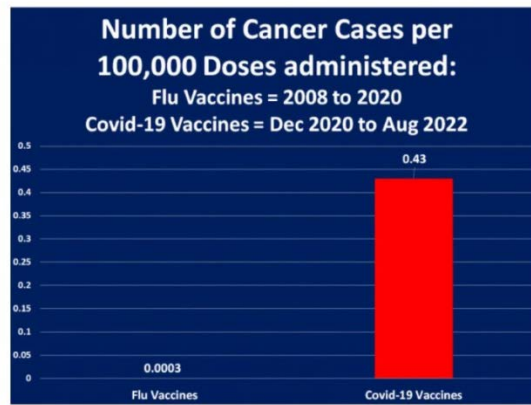

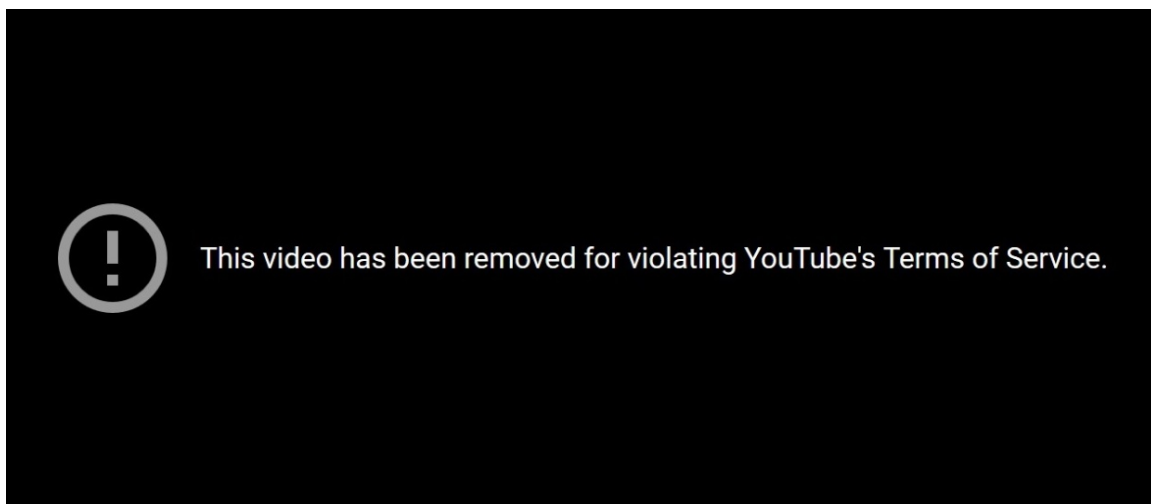
