Additionally, as Gilead pointed out in the federal district court, “Congress’s explicit extension of PREP Act immunity to claims involving a covered countermeasure’s ‘manufacture’ would be rendered meaningless if, as Plaintiffs suggest, the presence of a manufacturing defect prevented a product from being a covered countermeasure in the first place.” *Nowacki*, unpub order at 19. To accept plaintiffs’ argument and conclude that manufacturing defects prevent products from being considered “covered countermeasures” under the PREP Act, we would necessarily have to render some of the language of the PREP Act nugatory, in violation of our principles of statutory interpretation. *Esurance Prop & Cas Co*, 507 Mich at 508-509. We decline to do so here.

We apologize for the delay in responding as we had to research this further in order to verify the information. Our records indicate Mr. Daniel Nowacki was in the hospital between November 10, 2021 and November 24, 2021 and did receive the medication that is subject to the recall. The recall announcement was dated December 3, 2021 and when Mr. Daniel Nowacki was given Remdesivir we were not yet aware of the recall.

Two of the five doses in the course of treatment received by Mr. Daniel Nowacki involved the recalled lot #'s. Those doses were administered on November 10<sup>th</sup>, 2021 (lot #2141001-1a) and November 11<sup>th</sup>, 2021 (lot #2141001-1a). If you have any questions regarding health concerns, we recommend you follow up with your primary care provider. Additionally, we are including Gilead's recall announcement for your information.

# GOP lawmaker authors legislation to ban mRNA shots, label them 'weapons of mass destruction'

The legislator has written another bill to make ivermectin and hydroxychloroquine more readily available in the state.

Rep. Shane Mekeland, R-Clear Lake, has introduced a pair of bills that are designed to keep mRNA injections out of Minnesota. Additionally, the GOP lawmaker has written another bill to make ivermectin and hydroxychloroquine more readily available in the state.

The first bill, HF 3152, would ban “gene-based vaccines” from being administered in the North Star State. The bill defines gene-based vaccine as a vaccine that uses messenger ribonucleic acid (mRNA) technology, such as the kind used in the Pfizer and Moderna COVID-19 injections.

Alpha News has published several articles telling the stories of Minnesotans who say they were injured after receiving a COVID-19 vaccine.

The proposed law would allow licensing boards to take “appropriate licensing action” if a doctor is found to have administered an mRNA shot. Should the bill become law, anyone who administers an mRNA vaccine would be guilty of a misdemeanor and subject to a \$500 fine per incident.



Mekeland's second mRNA bill, which has been written but not formally introduced, would designate mRNA products and injections as "weapons of mass destruction" under state law. The Republican lawmaker shared a copy of the bill's language with Alpha News.

This legislation, known as the "mRNA Bioweapons Prohibition Act," would ban distribution or possession of mRNA products and injections in Minnesota. According to the language of the bill, "whoever knowingly manufactures, acquires, possesses, or makes readily accessible to another mRNA injections and products is guilty of a crime."

Current state law on weapons of mass destruction provides for a penalty of up to 20 years in prison and/or a fine of up to \$100,000.

Furthermore, the bill would require state and local government officials to use "all lawful means necessary" to enforce its provisions. Should officials fail to do so, the legislation would allow Minnesota residents to take legal action against those government officials.

Mekeland told Alpha News that the mRNA Bioweapons Prohibition Act would be formally introduced the next time the Minnesota House of Representatives is in session.

In addition to those bills, Mekeland has previously introduced HF 2230, a bill that requires pharmacies to make ivermectin and hydroxychloroquine available without a prescription. Both drugs have become popular medications for treating COVID-19 and other illnesses.

While HF 2230 requires pharmacies to make the two drugs available over-the-counter, it does not require pharmacies to carry either drug.

Last month, Arkansas passed a new state law which allows pharmacies to make ivermectin available over-the-counter. In Idaho, a similar bill was passed by the state legislature and awaits the signature or veto of the governor.

**609.712 REAL AND SIMULATED WEAPONS OF MASS DESTRUCTION.**

Subdivision 1. **Definitions.** (a) As used in this section, the following terms have the meanings given.

(b) "Biological agent" means any microorganism, virus, infectious substance, or biological product that may be engineered as a result of biotechnology, or any naturally occurring or bioengineered component of a microorganism, virus, infectious substance, or biological product, that is capable of causing:

(1) death, disease, or other biological malfunction in a human, an animal, a plant, or another living organism;

(2) deterioration of food, water, equipment, supplies, or material of any kind; or

(3) deleterious alteration of the environment.

(c) "Simulated weapon of mass destruction" means any device, substance, or object that by its design, construction, content, or characteristics, appears to be or to contain, or is represented to be, constitute, or contain, a weapon of mass destruction, but that is, in fact, an inoperative facsimile, imitation, counterfeit, or representation of a weapon of mass destruction that does not meet the definition of a weapon of mass destruction or that does not actually contain or constitute a weapon, biological agent, toxin, vector, or delivery system prohibited by this section.

(d) "Toxin" means the toxic material of plants, animals, microorganisms, viruses, fungi, or infectious substances, or a recombinant molecule, whatever its origin or method of production, including:

(1) any poisonous substance or biological product that may be engineered as a result of biotechnology or produced by a living organism; or

(2) any poisonous isomer or biological product, homolog, or derivative of such a substance.

(e) "Vector" means a living organism or molecule, including a recombinant molecule or biological product that may be engineered as a result of biotechnology, capable of carrying a biological agent or toxin to a host.

(f) "Weapon of mass destruction" includes weapons, substances, devices, vectors, or delivery systems that:

(1) are designed or have the capacity to cause death or great bodily harm to a considerable number of people through the release, dissemination, or impact of toxic or poisonous chemicals, or their precursors, disease organisms, biological agents, or toxins; or

(2) are designed to release radiation or radioactivity at a level dangerous to human life.

Subd. 2. **Weapons of mass destruction.** (a) Whoever manufactures, acquires, possesses, or makes readily accessible to another a weapon of mass destruction with the intent to cause injury to another is guilty of a crime and may be sentenced to imprisonment for not more than 20 years or to payment of a fine of not more than \$100,000, or both.

(b) It is an affirmative defense to criminal liability under this subdivision if the defendant proves by a preponderance of the evidence that the conduct engaged in:

(1) was specifically authorized under state or federal law and conducted in accordance with that law; or

(2) was part of a legitimate scientific or medical research project, or constituted legitimate medical treatment.

Subd. 3. **Prohibited substances.** (a) Whoever knowingly manufactures, acquires, possesses, or makes readily accessible to another the following, or substances that are substantially similar in chemical makeup to the following, in levels dangerous to human life, is guilty of a crime:

- (1) variola major (smallpox);
- (2) *bacillus anthracis* (anthrax);
- (3) *yersinia pestis* (plague);
- (4) botulinum toxin (botulism);
- (5) *francisella tularensis* (tularemia);
- (6) viral hemorrhagic fevers;
- (7) a mustard agent;
- (8) lewisite;
- (9) hydrogen cyanide;
- (10) GA (Tabun);
- (11) GB (Sarin);
- (12) GD (Soman);
- (13) GF (cyclohexymethyl phosphonofluoridate);
- (14) VX (0-ethyl, supdiisopropylaminomethyl methylphosphonothiolate);
- (15) radioactive materials; or
- (16) any combination of the above.

(b) A person who violates this subdivision may be sentenced to imprisonment for not more than 20 years or to payment of a fine of not more than \$100,000, or both.

(c) This subdivision does not apply to conduct:

- (1) specifically authorized under state or federal law and conducted in accordance with that law;
- (2) that is part of a legitimate scientific or medical research project; or
- (3) that constitutes legitimate medical treatment.

Subd. 4. **Simulated weapons of mass destruction; penalty.** Whoever manufactures, acquires, possesses, or makes readily accessible to another a simulated weapon of mass destruction with the intent of terrorizing another may be sentenced to imprisonment for not more than ten years or to payment of a fine of not more than \$20,000, or both.

Subd. 5. **Threats involving real or simulated weapons of mass destruction.** Whoever does the following with intent to terrorize another or cause evacuation of a place, whether a building or not, or



disruption of another's activities, or with reckless disregard of the risk of causing terror, evacuation, or disruption, may be sentenced to imprisonment for not more than ten years or to payment of a fine of not more than \$20,000, or both:

(1) displays a weapon of mass destruction or a simulated weapon of mass destruction;

(2) threatens to use a weapon of mass destruction; or

(3) communicates, whether directly or indirectly, that a weapon of mass destruction is or will be present or introduced at a place or location, or will be used to cause death, disease, or injury to another or to another's property, whether or not the same is in fact present or introduced.

Subd. 6. **Civil action to recover.** A person who violates this section is liable in a civil action brought by:

(1) an individual for damages resulting from the violation; and

(2) a municipality, the state, or a rescue organization to recover expenses incurred to provide investigative, rescue, medical, or other services for circumstances or injuries which resulted from the violation.

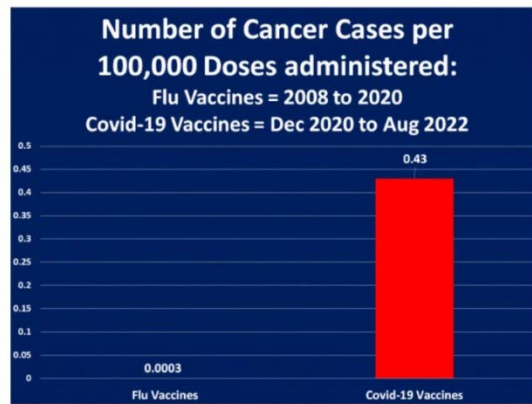

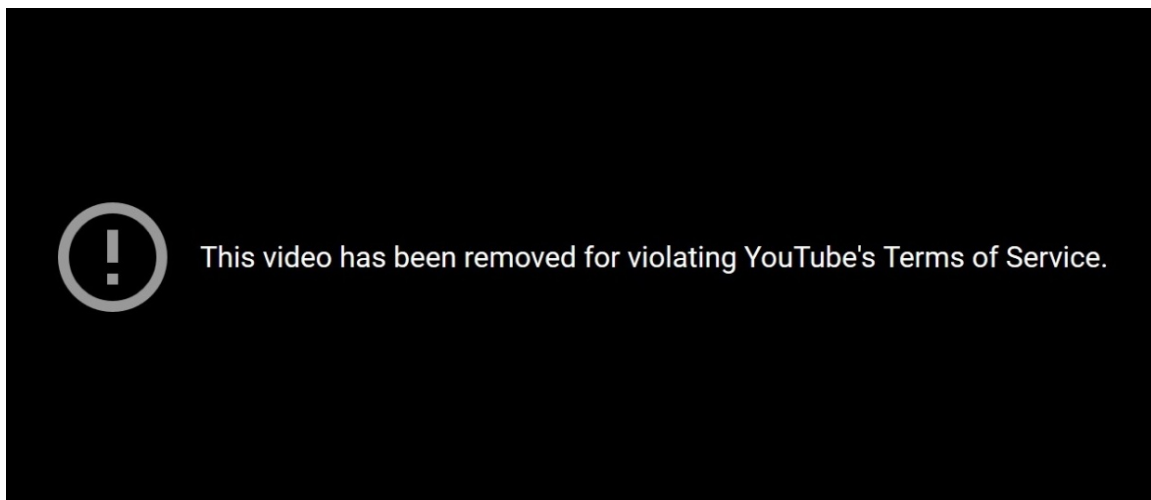
