HYPOTHETICAL QUESTIONS : (1) Would Ms. Letitia James demand that my Twitter account be closed under Document 3 ? 

Purchaser further acknowledges that the long-term effects and efficacy of the Vaccine are not currently known and that there may be adverse effects of the Vaccine that are not currently known. Further, to the extent applicable, Purchaser acknowledges that the Product shall not be serialized.

Not currently known?! I chose this Pfizer version because it was *secretly* imposed upon the **Republic of South Africa, the birthplace of Mr. Elon Musk**. Despite many voicemails and messages to Cornell Law School graduate, Mr. Douglas Lankler, General Counsel of Pfizer Inc, he refuses to respond to Tab 2.

New York Senate Bill S895B was co-sponsored by the following state senators:



Platform Moderation of “vaccine disinformation” vs Mrs. Jummai Nache

Pfizer Inc. is headquartered in New York. Senate Bill S895B was codified into the General Business Law of New York by the signature of Governor Kathy Hochul.

By early 2021, platform moderation regarding COVID-19 was already in-full-force. A focus of its censorship was the fraud that the Pfizer modRNA poison was a “vaccine” :

That fraudulent BigPharma ploy, using the familiar term “vaccine” to promote their modRNA poison, fundamentally misled the trusting public, and therefore implicitly denied their true informed consent.

This criminal fraud alone constitutes a “willful misconduct” that justifies the voiding of LIABILITY IMMUNITY under the PREP ACT. *

One of the earliest victims of “platform moderation” was UMinn Medical Assistant, Mrs. Nache :

Mrs. Nache and her family are devout Believers in the messiahship and Kingship of Jesus. Together they minister the Hope of Nations Fellowship of Churches (in Minnesota), where husband and father Dr. Philip Nache is Lead Pastor (<https://www.streamofnations.com/>)
I can assure you, nothing like the following took place at their ministry :

On September 26 2021, while Mrs. Nache was recovering from modRNA-induced blood clots **and resulting amputations**, Governor Kathy Hochul attended the Christian Cultural Center in (my former hometown of) Brooklyn, New York :

And say we owe this to each other, we love each other. **Jesus** taught us to loooooove one-another. And how do you show that love, but to care about each other enough to say ‘Please get vaccinated because I love you, I want you to live.’ I want our kids to be safe when they’re in schools. I want you to be safe when you go to a doctor’s office, or to a hospital and are treated by somebody, you don’t want to get the virus from them. You’re already sick or you wouldn’t be there!”*



Document 3 was a syndicated precursor to S895B. The precursors are *directly* connectable to a global crime syndicate. Under Biden, connections to BigPharma and Pfizer were touted with bravado ! Document 3? It was not signed by AutoPen; it was signed by Ms. Letitia James. It was also endorsed by a friend of George Soros, Minnesota Attorney General Mr. Keith Ellison :

His treasonous subversion of the First Amendment was not inadvertent. Ellison purposely subverted the right of constituents such as Mrs. Nache; denying their access to COVID-19 information which would have afforded their true informed consent.

Document 3? Its purpose was to ensure that modRNA mandates would be acceptable to the trusting public, and “democratically” enforceable. Like S895B, there was nothing Constitutionally defensible in Document 3. In this scenario, “platform moderation” is tantamount to BigPharma-endorsed censorship. The co-signing attorneys general fulfilled their roles as members of the *global COVID-19 Crime Syndicate*.

Global? Throughout this letter I have placed the precise medical term ‘vaccine’ in quotation. From the beginning of COVID-19, even at this simple terminology level, **deployment of the term “vaccine” against a naive trusting public constituted global criminal fraud.**

At the October 24 2021 World Health Summit (Berlin Germany), Bayer Pharmaceuticals CEO, Dr. Stefan Oelrich, admitted that modRNA is *not* a vaccine. The vials coerced into billions *world-wide* contained an experimental gene therapy, what Dr. Oelrich called “the leap**” :**

Decades ago (2003), during the first “**SARS,**” a Cornell Medical College graduate filed for a patent that portended enormous personal wealth. The applicant declared that an all-new modified RNA (self-replicating RNA) gene therapy was to be marketed as a “vaccine.” The United States Patent Office (USPO) responded as follows : *

These arguments are persuasive to the extent that an antigenic peptide stimulates an immune response that may produce antibodies that bind to a specific peptide or protein but is not persuasive in regards to a vaccine. The immune response produced by a vaccine must be more than merely some immune response but must be protective. As noted in the previous Office Action, the art recognizes the term “vaccine” to be a compound which prevents infection. Applicant has not demonstrated that the instantly claimed vaccine meets even the lower standard set forth in the specification, let alone the standard art definition, for being operative in this regards. Therefore, claims 5, 7, and 9 are not operative as an anti-HIV-1 vaccine and therefore lack patentable utility.

“Applicant has not demonstrated that the instantly claimed vaccine meets even the lower standard set forth in the specification, let alone the standard art definition.”



It is not happenstance that S895B specifies “*disinformation or misinformation*” as its purview. **But nowhere does this ruse specify the who or the what of gatekeepers! Who decides?!**

Hypothetical : If Pfizer CEO Albert Bourla had to pick who decides; a gatekeeper on “vaccine disinformation,” it would be a “health expert” . . . like **Cornell Professor Gary A. Koretzky** :



In the context of Nuremberg . . . Koretzky could/should be aware of the secret Pfizer *Purchase Agreements* (PAGE 2 ABOVE) . . . and the ‘*Post Authorization Adverse Events*’ (PAGE 15 ABOVE).

While Mrs. Nache lie in a hospital bed recovering from a modRNA-induced coma, Koretzky proffered his expertise. A mere four months after the EUA, during a Cornell Q&A panel of 12 April 2021, *The Science Behind COVID-19 Vaccines*; Koretzky claimed :



Document 2 : My Letter of 25 April 2025 to Mr. Elon Musk (DOGE)

Background : On Page 8 of Document 2 (enclosed), I reiterated a stark reality :

Not only did he write about it in 2012, but we were talking about it in there.

And I think I can speak for many Americans, when I can say ‘absolutely’ that he belongs in jail for that.”

Demand 2 must be executed immediately.




CONCLUSION


