Dear Attorney General Bondi,

I am writing to urge the Department of Justice to immediately drop all charges against Dr. Michael Kirk Moore, who is currently facing 35 years in federal prison for protecting patients from the COVID-19 vaccine.¹ Dr. Moore is a hero for refusing to inject an experimental vaccine into the arms of patients who did not wish to subject themselves or their children to a human experiment.

Dr. Moore is a decorated U.S. Navy Flight Surgeon with no criminal record. In the wake of the COVID-19 pandemic, he shifted his focus to serving the patients in his community. He courageously protected medical freedom by issuing vaccination record cards without administering the dangerous vaccines, allowing individuals and families in his community to live without fear of being demonized by society for being unvaccinated. Furthermore, he bravely destroyed thousands of vials of the COVID-19 vaccine and, at the request of some parents, injected saline into children whose parents wanted them to believe they got vaccinated without risking the deadly side effects. Dr. Moore has served this country in more ways than one, and he is a hero, not a criminal. He refused to succumb to the pressure of the mainstream narrative, the lies of the pharmaceutical industry, the so-called “science”, and the tyrannical mandates of the federal and state governments, and now, he is facing what could be the rest of his life in federal prison for doing so.

The charges brought initially by the corrupt Biden Justice Department against Dr. Moore are a blatant attempt to punish dissent and silence those who question the safety of experimental vaccines. Under Joe Biden’s Department of Justice, Democrats weaponized the agency against pro-lifers, J6ers, Catholics, parents at school board meetings, and doctors who protected patients. Dr. Moore exhibited resilience and courage by adhering to true medical research that exposed the dangers of the mRNA COVID-19 vaccine.

Historically, a vaccine is subjected to an average of 10-12 years of clinical trials before it is authorized for administration to the general population. Yet, under an Emergency Use Authorization (EUA), these vaccines were available to the public as early as 10 months after development. Furthermore, the COVID-19 vaccines were immediately authorized for use in pregnant women, which was unprecedented in the history of medicine.² The Vaccine Adverse Event Reporting System (VAERS) is a U.S. government system managed by the Centers for Disease Control and Prevention and the Food and Drug Administration used to track adverse reactions to vaccines since 1990. Since the rollout of the COVID-19 vaccine, there have been over one million adverse events reported in the U.S., including miscarriages, myocarditis, heart attacks, permanent disability, and death.³ The COVID-19 vaccine has injured and killed over a million people without a single charge brought against a vaccine manufacturer because they are protected under federal law. Meanwhile, a brave doctor who refused to inject it into his patients and issued vaccination record cards is facing 35 years in federal prison. He harmed no one and is innocent of wrongdoing.

Dr. Michael Kirk Moore deserves to be celebrated, not prosecuted, for his bravery in standing up to a system that prioritized control over public health.

I urge your Department of Justice to immediately drop all charges against Dr. Moore and co-defendants Kari Dee Burgoyne, Kristin Jackson Andersen, and Sandra Flores.

Dear Attorney General Bondi:

I write to renew my previous requests for the Department of Justice (DOJ) to open an investigation into former Director of the National Institute of Allergy and Infectious Diseases (NIAID) Anthony Fauci's testimony before the United States Senate Committee on Health, Education, Labor, and Pensions on May 11, 2021. This most recent request stems from new allegations that call into question the validity of Dr. Fauci's purported pardon.

In response to my questioning at the May 11, 2021 hearing, Dr. Fauci testified that "the NIH has not ever and does not now fund gain-of-function research in the Wuhan Institute of Virology".¹ In a subsequent hearing, I warned Dr. Fauci of the criminal implications of lying to Congress and offered him an opportunity to recant his previous statements. In response, Dr. Fauci stated that he had "never lied before the Congress" and "d[id] not retract that statement."²

On July 13, 2023 the House Select Subcommittee on the Coronavirus Pandemic released an email sent by Dr. Fauci on February 1, 2020, regarding a conference call concerning the origins of COVID-19, which included Dr. Fauci, Dr. Francis Collins, and several scientific researchers. In the email, Dr. Fauci acknowledges concerns that COVID-19 may have been genetically engineered due to the fact that gain-of-function research was occurring in Wuhan prior to the pandemic. Dr. Fauci wrote, "scientists in Wuhan University are known to have been working on gain-of-function experiments to determine that molecular mechanisms associated with bat viruses adapting to human infection, and the outbreak originated in Wuhan."³

In a paper entitled "Discovery of a rich gene pool of bat SARS-related coronaviruses provides new insights into the origin of SARS coronavirus," Dr. Zheng-Li Shi describes research conducted at the Wuhan Institute of Virology (WIV) and funded under NIAID Award R01AI110964. In that research, the spike genes from two uncharacterized bat SARS-related coronavirus strains, Rs4231 and Rs7327, were combined with the genomic backbone of another SARS-related coronavirus to create novel chimeric SARS-related viruses that showed cytopathic effects in primate epithelial cells and replication in human epithelial cells. These experiments combined genetic information from different SARS-related coronaviruses and combined them to create novel, artificial viruses able to infect human

cells. This research, conducted at the WIV and funded under NIAID Award R01AI110964, fits the definition of gain-of-function research.

In 2023, the Government Accountability Office (GAO) determined that the WIV and Wuhan University received NIH funding.⁴ The report noted that that NIH funded the WIV's project "Understanding the Risk of Bat Coronavirus Emergence" and included "genetic experiments to combine naturally occurring bat coronaviruses with SARS and MERS viruses, resulting in hybridized coronavirus strains." GAO also found that NIH funded the Wuhan University's collaboration with WIV on viral detection in the Yunnan province.

Under 18 U.S.C. § 1001, whoever "makes any materially false, fictitious, or fraudulent statement or representation" as part of "any investigation or review, conducted pursuant to the authority of any committee, subcommittee, commission or office of the Congress, consistent with applicable rules of the House or Senate" is subject to criminal fines and imprisonment of up to five years.

On January 19, 2025, Dr. Fauci was issued a full and unconditional pardon for any offenses that he may have committed or taken part in since 2014.⁵ Dr. Fauci was included among a group of individuals granted unprecedented preemptive pardons on President Joe Biden's final day in office. However, new information has revealed that these pardons were executed via autopen, with no documented confirmation that the President personally reviewed or approved each individual grant of clemency.⁶ According to reports, White House staff authorized the use of the autopen to issue the clemency documents.⁷ This raises serious constitutional and legal concerns about the legitimacy of Dr. Fauci's pardon.

For this reason, I renew my request that the DOJ investigate whether Dr. Fauci's statements to Congress on May 11, 2021 violated 18 U.S.C. § 1001 or any other applicable law.

Thank you for your prompt attention to this important matter.
