Dear President Trump :

An Emergency Use Authorization (EUA) was issued by the FDA on 11 December 2020 because it included **LIABILITY IMMUNITY**. The key facilitator of the EUA, and the “vaccine” mandates of the Biden Administration, was **censorship**.

The PREP Act specifies “willful misconduct” as basis for revocation of LIABILITY IMMUNITY. In a public interview of 2021 I asserted :

“The issue of willful misconduct is more than covered with evidence that is already in the public domain. In my opinion, we are well into **criminal conduct**. So we have the issue of voiding the LIABILITY IMMUNITY provision; we are way beyond having that voided with evidence that is already in the public domain.”

Regarding criminal conduct, I also documented in 2021 the following crime-against-humanity :

“The COVID-19 ‘vaccine’ was not created in response to the SARS-CoV-2 virus, but the exact opposite.”

Mr. Anthony Fauci confirmed this crime at the January 2024 House Select Committee on the Coronavirus Pandemic (See Epilogue – Part 1, Page 39 below).

LIABILITY IMMUNITY : Underbelly of Year-2020 and Ongoing Criminality

Enclosure 2 : My Letter of 6 August 2025 to Elon Musk attorney Mr. Joel Kurtzberg presents how LIABILITY IMMUNITY remains central to their evasion of criminal prosecution. **I present that their devotion to LIABILITY IMMUNITY requires subversion of the First Amendment.** The focus of their censorship is modRNA technology, hence their slithering behind the *compound* ruse :

“vaccine disinformation”

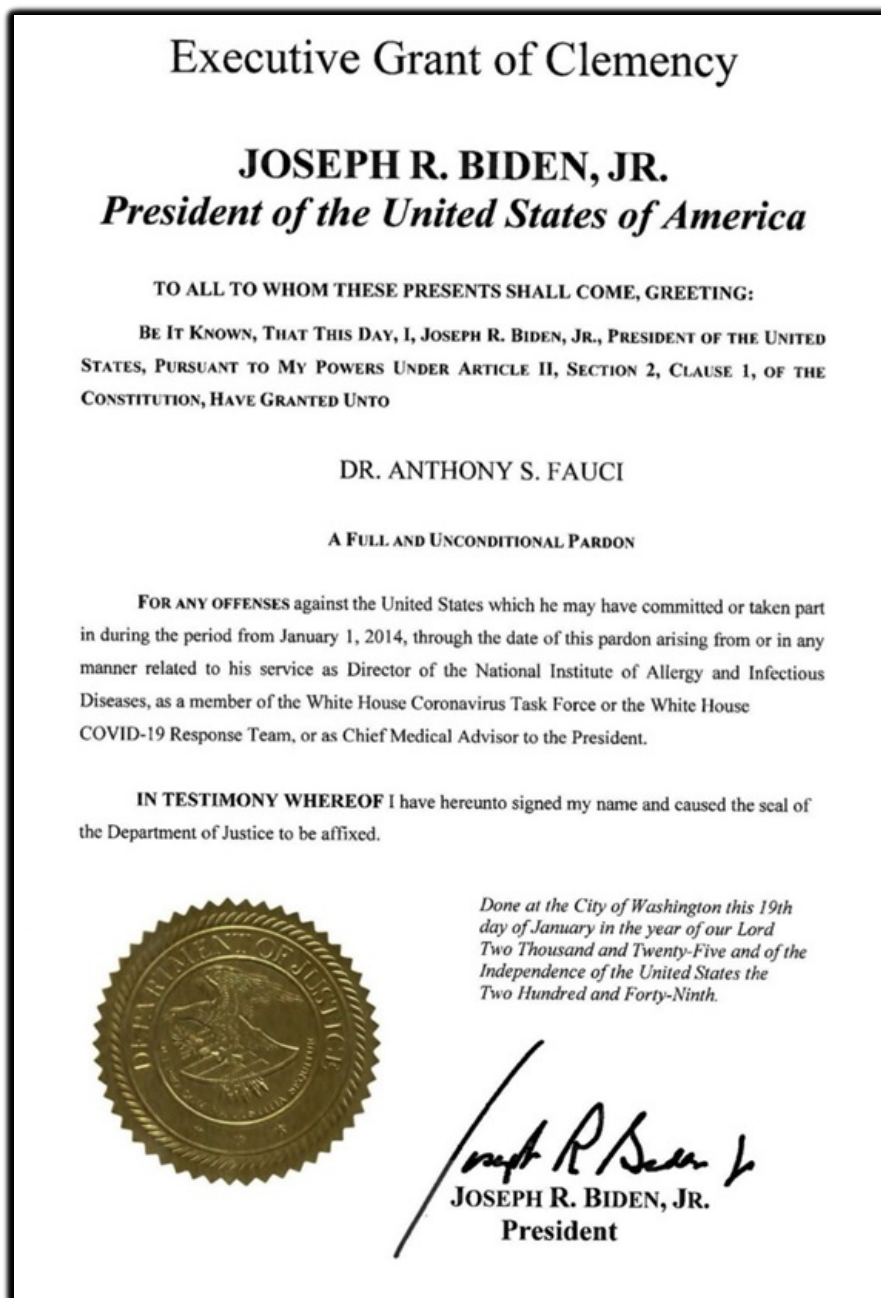

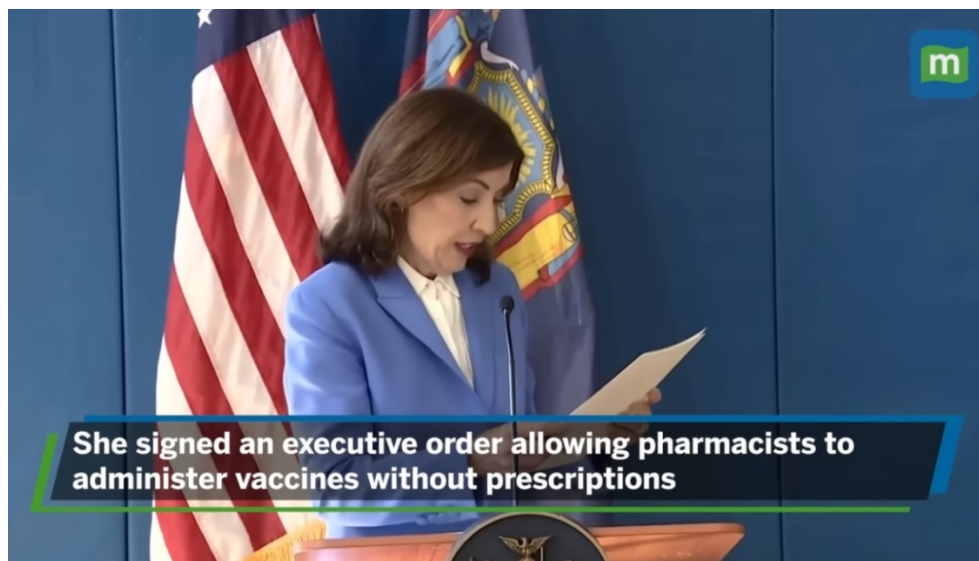
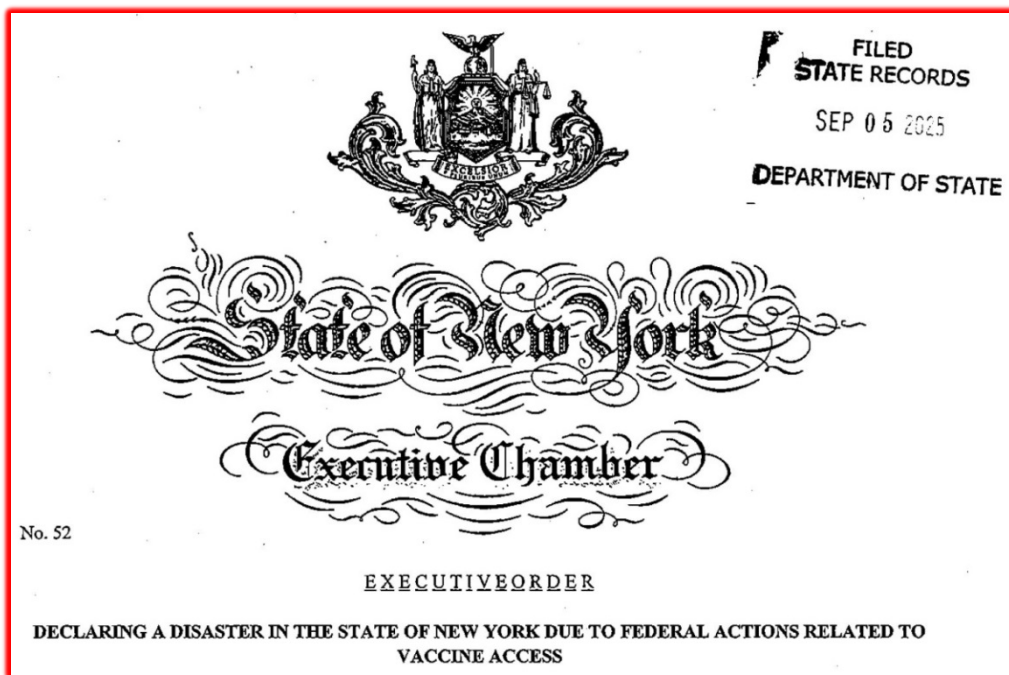

Ongoing Ponerology of the COVID-19 Crime Syndicate : New York Governor Kathy Hochul

The day after your 4 September 2025 White House BigTech gala (See Inside Sleeve – Rear) which hosted accommodating recipients of the Letitia James “vaccine disinformation” letter of 24 March 2021, Governor Hochul signed Executive Order #52 :



Simultaneous with EO-52, Health Commissioner Dr. James McDonald issued a “Health Advisory” that recommends that *all* get injected with the latest Pfizer modRNA poisons. **Consistent with prior COVID-19 crimes, these servants failed to inform : Are the pharmacists that are now authorized to “administer” modRNA poisons shielded by LIABILITY IMMUNITY?** This routine is called Lying-by-Omission; a central operative of ponerology.

Ongoing CRIMINALITY of Pfizer CEO Mr. Albert Bourla

Immediately before the 2020 presidential election, Mr. Bourla and Mr. Anthony Fauci conspired to ensure that Operation Warp Speed, and its “father,” was not accredited prior to installation of their “vaccine” candidate; the AutoPen that signed, the notorious Fauci pre-pardon (See Page 5 above).



In late 2020 Bourla filmed himself celebrating the alleged trial results from the modRNA poison that he marketed as a “vaccine,” and fraudulently claimed was “safe & effective.”

That the Pfizer “vaccine” trials reeked of criminal fraud was of no concern to the COVID-19 Crime Syndicate. *Why not?! Answer :*

LIABILITY IMMUNITY !

But . . . what was the Pfizer legal approach to nations where LIABILITY IMMUNITY does not exist? Such as the great nation of India? The Elon Musk birthplace of South Africa?

Enclosure 3 : My letter of 28 May 2024 to Corporate Attorney Mr. Douglas Lankler focused on a secret Pfizer contract of March 30 2021 with the Purchaser (South Africa) :

Purchaser Acknowledgement.

Purchaser acknowledges that the Vaccine and materials related to the Vaccine, and their components and constituent materials are being rapidly developed due to the emergency circumstances of the COVID-19 pandemic and will continue to be studied after provision of the Vaccine to Purchaser under this Agreement. Purchaser further acknowledges that the long-term effects and efficacy of the Vaccine are not currently known and that there may be adverse effects of the Vaccine that are not currently known. Further, to the extent applicable, Purchaser acknowledges that the Product shall not be serialized.

Ongoing CRIMINALITY of Pfizer CEO Mr. Albert Bourla

Immediately following the first presidential debate (October 2020), wherein Joe Biden declared his intention to mandate the “vaccine,” Mr. Bourla celebrated with a memo to Pfizer staff :

“There are three key areas where, as with all vaccines, we must demonstrate success in order to seek approval for public use. First, the vaccine must be proven effective, meaning it can help prevent COVID-19 disease in at least a majority of vaccinated patients. Second and equally important, the vaccine must be proven safe, with robust safety data generated from thousands of patients. And finally, we must demonstrate that the vaccine can be consistently manufactured at the highest quality standards.”

Refuting this platitude, Bourla was aware that he **was not in trials with a standard art vaccine**. Instead, participants were injected with a contraption so poisonous that previous modRNA animal trials (SARS-CoV-1) resulted in complete death (ferrets). Bourla was fully-aware that Operation Warp Speed had skipped the animal trials, and **would be seeking an EUA, not approval**.

The 2020 election occurred on November 3. Installation of Joe ‘Vaccine Mandate’ Biden was announced on Saturday November 7. On Monday November 9 2020, **as part of an agreed-to delay**, Bourla announced his trial results, and emphasized that he would only offer his modRNA poisons **under an EUA**, and therefore **only if Pfizer was shielded by : LIABILITY IMMUNITY**.

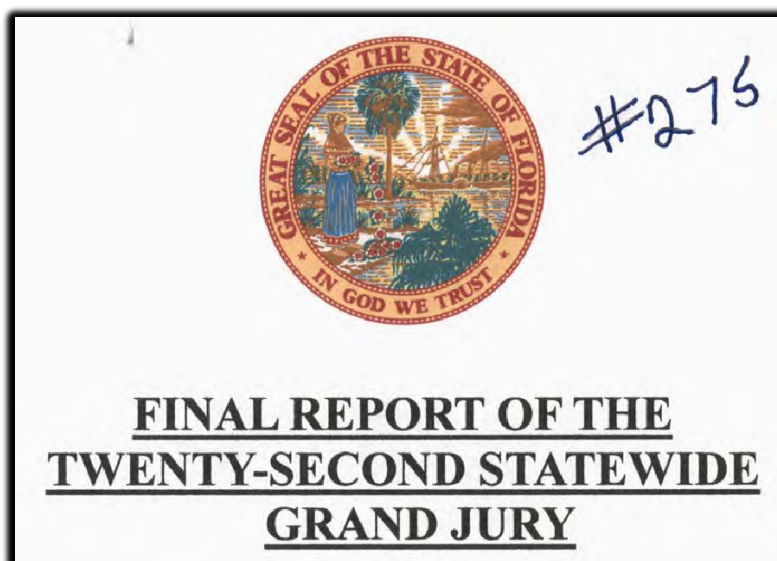

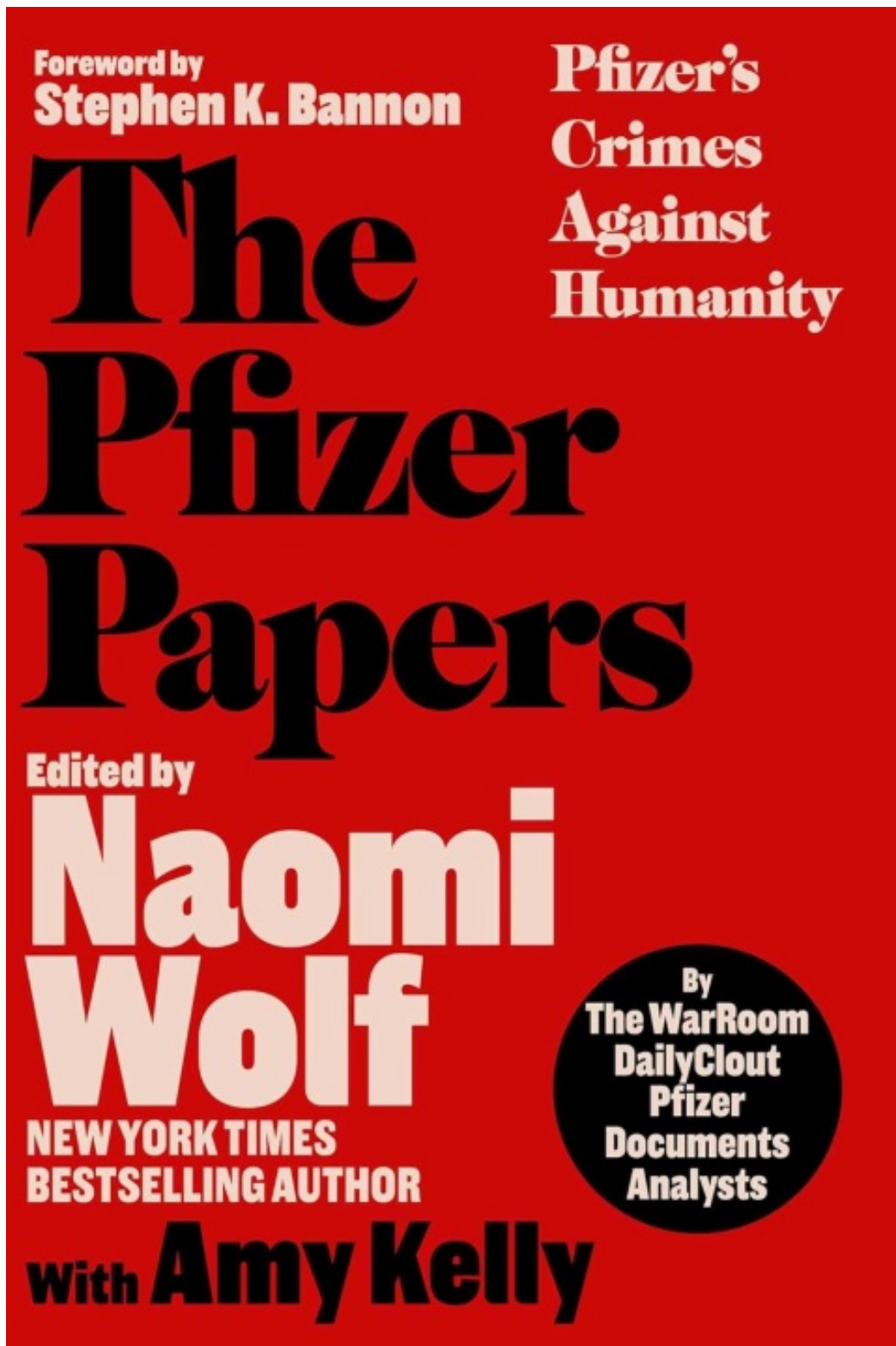

On Page 4 of my letter of 20 March 2025 to Missouri Attorney General Mr. Andrew Bailey, I presented **the 18 February 2025 CNBC interview of Mr. Bourla** (screenshot) :

Mr. Bourla was asked a very simple question, **one that he refused to answer** :



CNBC Question : ‘Vaccine manufacturers like yourself largely shielded from liability; if the product is safe & effective, what is the need to continue to shield, to have these liability shields, and what happens if those shields are changed or go-away completely?’

Bourla non-answer : If the product is not safe & effective we never get **approval** from FDA or from the other health authorities. They are very strict when they are approving products, particularly for vaccines, because exactly it’s given to healthy people. However in the system that litigations can flourish, anyone can create demands that uh, the accident in the car happened because of the vaccine. And uh with a jury, it’s going to be, it may be a flip of the coin. And this is I think why that Congress, it was not an administration, had passed this legislation. That is protecting those that they have **approval** from the FDA from certain liabilities. <sic>

“Approval”?! Bourla is gleefully aware of the key PREP Act distinctions; approved versus merely authorized, and that the latter provides **LIABILITY IMMUNITY**. As long as his HHS lackeys continue to assert a COVID emergency, the Pfizer modRNA contraption is shielded from litigation.

Terrorism of the Nation-Destroying COVID-19 Crime Syndicate *Page 1 of 2*

On the FBI website we find their definition of domestic terrorism / terrorists :

“Violent, criminal acts committed by individuals and/or groups to further ideological goals stemming from domestic influences, such as those of a political, religious, social, racial, or environmental nature.”

Such as rigging elections by delaying Pfizer “vaccine” trials announcement?

*“In November 2024, shortly after the election, Dr. Dormitzer approached a representative from the GSK human resources team to speak about a potential relocation abroad. 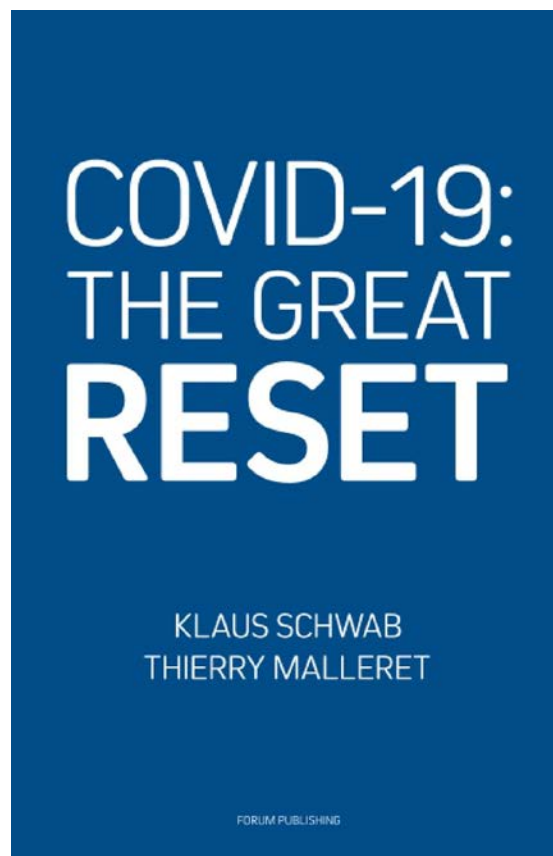
